Re: Summary of Cultural Resources Records Search for the Roseton Avenue Reservoir Tank and Booster Station Project, Artesia, California

To Whom It May Concern,

ECORP was retained by Golden State Water Company to conduct a cultural resources records search for the proposed Roseton Avenue Reservoir Tank and Booster Station Project in Los Angeles County, California. The Project Area is located at 17456 Roseton Avenue in the City of Artesia (Figure 1). Golden State Water Company proposes to install a 750,000-gallon above-ground potable water storage tank, booster pump station, and associated fencing, lighting, control panels and appurtenances at the existing Roseton Well site. Because the area proposed for the well has been heavily disturbed through development, ECORP did not conduct a formal survey of the Project Area. In support of the Project, ECORP requested a search of California Historical Resources Information System (CHRIS) from the South Central Coastal Information Center (SCCIC) and a search of the Sacred Lands File from the Native American Heritage Commission (NAHC). This letter report summarizes the results of these records searches.

RECORDS SEARCH

CHRIS Records Search Methods

ECORP requested a CHRIS records search from the SCCIC at California State University-Fullerton on December 10, 2021. The purpose of the CHRIS records search was to determine the extent of previous surveys within a 1-mile (1,600-meter) radius of the Proposed Project location, and whether previously documented pre-contact or historic archaeological sites, architectural resources, or traditional cultural properties exist within this area.

CHRIS Records Search Results

ECORP received the CHRIS records search results from the SCCIC on February 14, 2022. The CHRIS records search confirmation, report list, and resources list can be found in Attachment A. The records search results revealed that a total of 25 cultural resource investigations have been conducted within 1 mile of the property between 1974 and 2016 (Table 1). None of these studies overlapped the Project Area. These studies revealed the presence of a pre-contact habitation site and historic-period sites including buildings and railroad lines/spurs.

The CHRIS records search also determined that one previously recorded pre-contact cultural resource and six historic-period resources are located within 1 mile of the Project Area (Table 2). The pre-contact site is believed to be associated with Native American occupation of the vicinity. Historic-period resources consist of the Union Pacific Railroad, four historic buildings on the Cerritos College campus, and one residence.

SACRED LANDS FILE COORDINATION

Sacred Lands File Coordination Methods

ECORP contacted the NAHC on December 10, 2021, to request a search of the Sacred Lands File for the Project Area. This search was requested to determine whether Sacred Lands have been recorded by California Native American tribes within the Project Area because the Sacred Lands File is populated by members of the Native American community with knowledge about the locations of tribal resources. In requesting a search of the Sacred Lands File, ECORP solicited information from the Native American community regarding Tribal Cultural Resources, but the responsibility to formally consult with the Native American community lies exclusively with the federal and local agencies under applicable state and federal law. ECORP was not delegated authority by the lead agencies to conduct tribal consultation.

Sacred Lands File Results

ECORP requested a search of the Sacred Lands File from the NAHC on December 10, 2021. As of the time of the submission of this report, the results of the Sacred Lands File search from the NAHC are still pending and have not been received by ECORP. ECORP will forward all information to the lead agency upon receipt of the results of the Sacred Lands File search from the NAHC.

SUMMARY

The results of the CHRIS records search as received from the SCCIC indicate that no cultural resources were previously recorded within the Project Area. The results of the Sacred Lands File search as conducted by the NAHC have not been received by ECORP at the time of this report. ECORP will forward the results of the Sacred Lands File search to the lead agency upon receipt from the NAHC.


