**Draft Initial Study / Mitigated Negative Declaration,  
Environmental Assessment, and Draft Finding of No Significant Impact  
for the proposed  
Soboba Band of Luiseño Indians' Septic to Sewer Conversion Project**

Pursuant to California Environmental Quality Act (CEQA) Section 21092 & CEQA Guidelines Section 15072 and National Environmental Policy Act & Indian Health Service Environmental Review Manual

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (SWRCB) Division of Financial Assistance and the U.S. Department of Health and Human Services - Indian Health Service (IHS) have jointly prepared and are circulating the Initial Study/Mitigated Negative Declaration – Environmental Assessment (IS/MND–EA) for the Soboba Band of Luiseño Indians' Septic-to-Sewer Conversion Project (Project) in Riverside County. The Project includes approximately 19.6 miles of sewer pipelines, lift stations, and staging areas, primarily within the Soboba Band of Luiseño Indians' 8,320-acre Reservation, with some off-Reservation segments in the City of San Jacinto and unincorporated County of Riverside. The Project site is not present on any of the lists enumerated under section 65962.5 of the Government Code.

The SWRCB and IHS are required to fulfil the requirements of the California Environmental Quality Act (Public Resources Code 21000 et seq.) and National Environmental Policy Act (42 United States Code §4321-4370), respectively. The IS/MND–EA assesses the environmental impacts resulting from the Project. The determined environmental impacts would be less than significant with environmental commitments, protection measures, and mitigation measures.

**NOTICE IS ADDITIONALLY HEREBY GIVEN** that SWRCB and IHS invites and will receive public comments on the Project in accordance with this notice, and that the SWRCB intends to adopt the IS/MND–EA for the Project in accordance with the CEQA Guidelines.
