STAFF REVIEW OF THE PROPOSITION 84 STORMWATER GRANT PROGRAM (SWGP) IMPLEMENTATION ROUND 1 PROJECTS PENDING APPROVAL

DISCUSSION

On October 3, 2012, the State Water Resources Control Board (State Water Board) adopted Resolution No. 2012-0050, approving the Stormwater Grant Program (SWGP) Round 1 Implementation Funding List. The Funding List included two lists of projects: 1) the Recommended Funding List, and 2) the Projects Pending Approval List. The Projects Pending Approval are those that staff recommend for funding only if the applicant makes specific changes to the project or provides information to address questions regarding the project.

On December 4, 2012, the State Water Board adopted Resolution No. 2012-0063, approving the addition of the City of Anaheim's Brookhurst Street South Low Impact Development Project to the SWGP Round 1 Implementation Projects Pending Approval List.

Resolution No. 2012-0050 authorized the Deputy Director of the Division of Financial Assistance (Division), or designee, to add projects from the Projects Pending Approval List to the Recommended Funding List portion of the SWGP Implementation Round 1 projects if information provided by the applicants adequately addressed issues identified by the technical reviewers.

Based on the applicants' responses, staff recommends the following eleven projects for addition to the Recommended Funding List:
