#### BACKGROUND

The purpose of the Draft Funding Guidelines is to establish the process and criteria that the State Water Board will use to solicit applications, evaluate, and select proposals, and award grants for projects funded by the Proposition 1 Groundwater Grant Program. Proposition 1 was passed by voters in November 2014 and provided \$900 million for a groundwater sustainability program (Assembly Bill 1471, Chapter 10). The State Water Board will administer \$800 million for projects that prevent or cleanup contamination of groundwater that serves (or has served) as a source of drinking water.

#### **PROCEDURAL MATTERS**

At the May 17, 2016 Board Meeting, the Board will consider adoption of the Funding Guidelines. Participants will be given an opportunity to speak to the Board directly and summarize and supplement their written materials with oral presentations during the Board Meeting. There will be no sworn testimony or cross-examination of participants. However, the State Water Board and its staff may ask clarifying questions.

No new evidence (e.g. photographs, data, and testimony) may be submitted at the Board Meeting and all comments will be treated as non-evidentiary policy statements. To ensure a productive and efficient meeting in which all participants have an opportunity to participate, oral presentations at the Board Meeting may be time-limited.
