NOTICE OF PROPOSED AMENDMENT OF THE CLEAN WATER STATE REVOLVING FUND (CWSRF) PROJECT PRIORITY LIST (PPL)

This announcement serves to inform interested parties that the Executive Director of the State Water Resources Control Board (State Water Board) intends to amend the CWSRF PPL, in accordance with the authority provided in Section IV.E.3 of the [Policy for Implementing the CWSRF for Construction of Wastewater Treatment Facilities \(Policy\)](#). The State Water Board adopted the current CWSRF PPL on June 15, 2010. Per Section IV.E of the Policy, the State Water Board or the Executive Director are authorized to amend the PPL. Additional projects were added to the PPL on April 12, 2011 and December 5, 2011.

The proposed third amendment to the CWSRF PPL (Amendment No. 3) will add projects with applications currently under review by the Division, which may be approved for financing in the near future. Adding the proposed projects will allow them to qualify for financing.
