What are Beneficial Uses?

 Beneficial uses are the cornerstone of water quality protection and reflect the goals for a water body

 Provide a framework for establishing Water Quality
 Objectives to protect specific water bodies from pollutants and contaminants

- Aquaculture

Draft Beneficial Uses

- Tribal Tradition Culture
- Tribal Subsistence Fishing
- Subsistence Fishing







Tribal Tradition & Culture (CUL)

Uses of water that support the cultural, spiritual, ceremonial, or traditional rights or lifeways of California Native American Tribes, including, but not limited to: navigation, ceremonies, or fishing, gathering, or consumption of natural aquatic resources, including fish, shellfish, vegetation, and materials.

Tribal Tradition & Culture Use

- Specific to California Native American Tribal practices & sovereignty
- Designed to protect traditional and cultural activities
- Examples include:
 - Water emersion ceremonies
 - Gathering aquatic materials, such as reeds for basket weaving
 - Collection and use of aquatic plants used for food and medicines





California Native American Tribe

CALIFORNIA NATIVE AMERICAN TRIBE: A federally-recognized California tribal government listed on the most recent notice of the Federal Register or a non-federally recognized California tribal government on the California Tribal Consultation List maintained by the California Native American Heritage Commission.

Tribal Subsistence Fishing (T-SUB)

Uses of water involving the non-commercial catching or gathering of natural aquatic resources, including fish and shellfish, for consumption by individuals, households, or communities of California Native American Tribes to meet minimal needs for sustenance.

Tribal Subsistence Fishing Use

 Specific to California Native American Tribal practices— Respects Native American sovereignty

 Protects people who consume of fish and shellfish at levels consumed by California Native American Tribes

Does not protect the fish or their habitat





Subsistence Fishing

Uses of water involving the non-commercial catching or gathering of natural aquatic resources, including fish and shellfish, for consumption by individuals, households, or communities, to meet minimal needs for sustenance.

Subsistence Fishing

 Protects non-tribal people who consume fish and shellfish at levels above the average recreational fisher.

 Consumption may be due to cultural practices (not indigenous), for economic reasons, or both

Also does not protect the fish or their habitat





Next Steps

Assuming the State Water Board adopts the beneficial uses:

- Regional Boards may designate the beneficial uses to specific water bodies (Basin Plan Action)
- Water Quality Objectives may be developed (Regionwide or Statewide action)
- Implementation programs may be developed

- What guidance will the SWRCB provide for designating these uses?
 - "To designate the Tribal Tradition and Culture or Tribal Subsistence Fishing beneficial uses...a California Native American Tribe must confirm the designation is appropriate."
 - "No confirmation is required to designate the Subsistence Fishing beneficial use"
 - "The two subsistence fishing beneficial uses assume a higher rate of consumption of fish or shellfish than [other] beneficial uses"

- Will the Tribal Traditional and Cultural beneficial use require flow objectives or otherwise affect water diversions?
 - It is not anticipated that flow objectives would be developed to support CUL beneficial use
 - These are Water Quality, not Water Rights
 beneficial uses
 - As Part of a Clean Water Act section 401 water quality certification, these beneficial uses must be considered

- Will the two subsistence fishing beneficial uses protect fish habitat and flow to guarantee a quantity of fish?
 - These uses support human health. Draft definitions were updated winter, 2016
 - Existing beneficial uses protect habitat for fish (e.g. WARM, COLD, SPWN, MIGR)
 - o "The Tribal Subsistence Fishing and Subsistence Fishing beneficial uses are not to protect or enhance fish populations or aquatic habitats."

 Are these proposed beneficial uses already being protected through other beneficial uses, or other permits?

It possible to protect these uses with TMDLs?

- Are these proposed beneficial uses already being protected through other beneficial uses, or other permits?
 - Tribal activities and fish consumed at subsistence levels are not covered by existing uses
- Is it possible to protect these uses with TMDLs?
 - TMDLs generally are implemented if beneficial uses are impaired

- How will these uses interact with beneficial uses adopted by the North Coast Regional Water Board?
 - "The Tribal Subsistence Fishing Water Quality Objective would not apply to waters designated by the North Coast Regional Water Board's basin plan with the beneficial uses for Native American Culture (which includes subsistence fishing)...In the future, if the North Coast Regional Water Board amends its basin plan with the Provisions' beneficial uses for CUL, T-SUB, and SUB, such designation would determine which of the Mercury Water Quality Objectives would apply."

- How does the statewide adoption of these uses affect their incorporation into basin plans?
 - Adoption will make them readily available for (but does *not* require) designation
 - Regional Water Boards go through the public process to amend their basin plans to set forth the use or to establish designations

- When would the Regional Water Boards designate these beneficial uses?
 - Generally, the need to designate is identified during triennial reviews
 - Regional Water Boards go through the public process to amend their basin plans
- What are the criteria needed to designate?
 - O Whether the beneficial use is occurring?

- Are the proposed tribal beneficial uses restricted to "tribal" or "sovereign" lands or waters?
 - No. The waterbody may be on tribal lands, historic tribal lands, or land that is or could be used by tribes.

- Will information be available identifying the specific tribal activity(ies) that justifies the designation?
 - Yes. Information concerning the types of activities will be publically available, as they relate to health risks and exposure. However, out of respect for Native American culture, specific ceremonial practices that are not relevant to consideration of water quality will not be available.

- In the absence of water quality objectives, how are the uses going to be protected?
 - The uses must first be incorporated into basin plans and designated to water bodies
 - Existing water quality objectives may be used or new objectives may be developed
 - The regional water board will develop new objectives if necessary
