Dear Mr. Isorena:

With this letter, please find the Marin/Sonoma Mosquito and Vector Control District's (MSMVCD) annual report for 2012 regarding the NPDES permit referenced above.

MSMVCD was in compliance with the permit in 2012; there were no violations. The best management practices (BMPs) outlined in MSMVCD's Pesticide Application Plan (PAP) were appropriate and coincided with an Integrated Vector Management Program. The BMPs in MSMVCD's current PAP will continue to be utilized in 2013.

MSMVCD performed visual monitoring of >10% of individual application sites identified as "Waters of the U.S." until July 2012. The SWRCB notified the permit holders in a letter to the Mosquito and Vector Control Association of California, dated July 13, 2012, that because the visual monitoring requirements were "interfering with the need for maximal efficient application to adequately protect human health from vector-borne diseases like West Nile virus," that the visual monitoring was no longer required by individual Districts. The visual monitoring performed indicated that there were no observable changes relative to water quality in conjunction with the applications (see attached monitoring sheet, Attachment B).

The BMPs currently included in MSMVCD's PAP were effective in 2012 and are expected to be effective and consistent with an Integrated Vector Management Program in 2013. Such BMPs for example, include: public relations/education, mosquito source reduction, biological control (e.g. mosquito fish), calibration of mosquito adulticide and larvicide equipment, and pesticide spill and spill prevention training.

At this time, there are no recommendations for BMP modifications given that there were no violations of the permit in 2012. Please see the map included with the attached 2012 Annual Report depicting the application areas in Marin and Sonoma counties (Attachment C).

The dosage, concentrations, and amounts of the materials applied were derived from the product labels. Please see the application log included with the attached 2012 Annual Report (Attachment A).

I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted. 1. Annual Report

a. Executive Summary

The Marin/Sonoma Mosquito and Vector Control District (District) complied with the applicable components of the General NPDES Permit for Biological and Residual Pesticide Discharges from Vector Control Applications (General Permit). The District is a member of the Mosquito and Vector Control Association of California (MVCAC) NPDES Permit Coalition (Coalition). The Coalition conducted all required chemical and physical monitoring. The results of the Coalition's monitoring will be included in the Coalition Annual Report that will be sent separately to the SWRCB and Regional Boards. The best management practices (BMPs) outlined in MSMVCD's Pesticide Application Plan (PAP) were appropriate and coincided with the District's Integrated Vector Management Program. The BMPs in MSMVCD's current PAP will continue to be utilized in 2013.

The District made 1,056 applications to waters of the U.S. during the 2012 calendar year. The log of these applications can be found in Attachment A. The District performed visual monitoring of >10% of individual application sites identified as "Waters of the U.S." until July 2012. The visual monitoring completed by the District in the first half of the year showed no observable change in water quality between the background, event, and post event time periods (see Attachment B). The SWRCB notified the permit holders in a letter to MVCAC dated July 13, 2012 that because the visual monitoring requirements were "interfering with the need for maximal efficient application to adequately protect human health from vector-borne diseases like West Nile virus," that the visual monitoring was no longer required by individual Districts.

b. Summary of Monitoring Data

The District began the year by complying with the visual monitoring requirements of the permit. See Footnote 1 of Tables C-1 and C-2 in the Amended Water Quality Control Order No. 2011-0002-DWQ, General Permit No. CAG990004. These requirements required a tremendous amount of time to monitor including a number of revisits to specific sites to gather the necessary information. Most critically, time spent revisiting old sites caused delay in getting to new sites. Given the short lifecycle of the mosquito, this greatly exacerbated the task of looking for and treating mosquito breeding sites early in their lifecycle when treatment is more concentrated and effective. Recognizing the need of mosquito control districts to quickly find and treat mosquito breeding sites to prevent the spread of disease, such as West Nile virus, the SWRCB issued a letter to MVCAC dated July 13, 2012 that indicated the visual monitoring requirement would no longer be required to individual Districts.

Per the instructions in the letter, the Coalition will provide information on the incidence of West Nile virus and other similar public health threats in the Coalition's annual report.

For the reasons stated above, the District will no longer be collecting visual monitoring data.

The BMPs currently in place in the District's PAP were effective in 2012 and are expected to be effective and consistent with an Integrated Vector Management Program in 2013. Such BMPs for example, include: public relations/education, mosquito source reduction, biological control (e.g. mosquito fish), calibration of mosquito adulticide and larvicide equipment, and pesticide spill and spill prevention training.

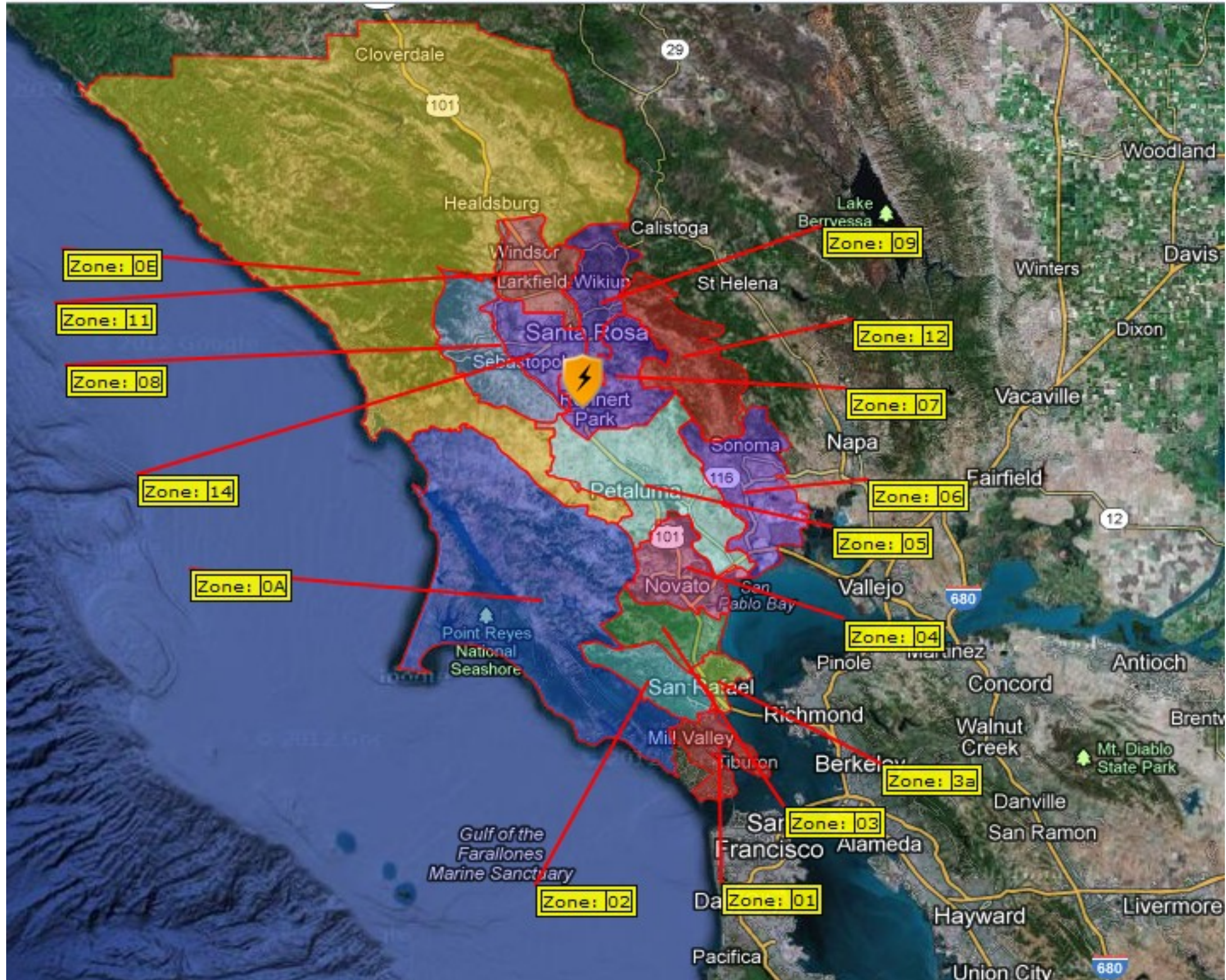
