# PROPOSED 2020 – 2025 NONPOINT SOURCE PROGRAM IMPLEMENTATION PLAN

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will receive public comments on the proposed 2020 – 2025 Nonpoint Source Program Implementation Plan.

## **BACKGROUND**

The proposed 2020-2025 Nonpoint Source Program Implementation Plan (Plan) has been prepared by the State Water Resources Control Board (State Water Board), the Regional Water Quality Control Boards (Regional Water Boards) and the California Coastal Commission, collectively the co-lead agencies. The proposed 2020-2025 Nonpoint Source Program Implementation Plan presents the general goals and objectives of the co-lead agencies for addressing nonpoint source pollution over the timeframe of July 2020 to June 2025.

The proposed Plan was prepared to meet the requirements of Clean Water Act section 319 (CWA 319) and the Coastal Zone Act Reauthorization Amendments (CZARA) of 1990. CWA 319 requires all states to have a management program for controlling nonpoint source pollution to waters of the state and for improving the quality of such waters. In addition, CZARA requires coastal states to have a Coastal Nonpoint Pollution Control Program (CNPCP).

The proposed Plan supports the mission of the State Water Board to preserve, enhance, and restore the quality of California's water resources and drinking water for the protection of the environment, public health, and all beneficial uses by reducing discharges of nonpoint source pollution to waters of the state and mitigating impacts from nonpoint source pollution.
