NOTICE OF PUBLIC MEETING

INFORMATIONAL ITEM ON THE STATUS OF ONCE-THROUGH COOLING INTERIM MITIGATION AND THE USE OF INTERIM MITIGATION FUNDS

The statewide Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling Policy or OTC Policy) requires power plant owners and operators to implement measures to mitigate interim impingement and entrainment impacts resulting from their cooling water intake structures. The interim mitigation period commenced on October 1, 2015, and continues up until owners and operators achieve final compliance with the OTC Policy.

State Water Board staff will present a joint informational item with the Ocean Protection Council (OPC) and the California State Coastal Conservancy (SCC) during the September 4, 2018 Board Meeting. The presentation will include an update on the 2015-2016 and 2016-2017 interim mitigation funds, grant guidelines developed by the OPC to solicit competitive projects to receive interim mitigation funds, and projects selected by the SCC to receive interim mitigation funds.
