BACKGROUND

The Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling Policy or OTC Policy) requires that the SACCWIS convenes periodically to ensure that implementation of the OTC Policy will not cause disruption in the State of California's electrical power supply. All meetings of the SACCWIS are open to the public and the SACCWIS will hear public comment on any items under consideration.

The meeting will include a presentation and the Committee's consideration of approval of the Draft SACCWIS Report, which contains information on a request from the Los Angeles Department of Water and Power to extend the OTC Policy compliance date for Scattergood Generating Station until December 31, 2029.
