NRG California South LP ("NRG California South"), owner of the Ormond Beach Generating Station (OBGS), submits its response to the State Water Resources Control Board's (SWRCB) December 11, 2017 letter in which the SWRCB requested monthly and total intake volume and actual annual impingement data in total pounds for October 1, 2016 – September 30, 2017. The information request was received December 20, 2017. Response to this information request will be used to calculate the interim mitigation payments for this period in compliance with the SWRCB's Policy on the Use of Coastal and Estuarine Water for Power Plant Cooling (OTC Policy), Option 2.C(3)(b). Below are the requested total intake volume and annual impingement in pounds for October 1, 2016 - September 30, 2017. Supporting data are presented in Attachment A to this letter.

1. Total intake volume for October 1, 2016 – September 30, 2017 = 30,666.70 million gallons (MG)
2. Total actual annual impingement = 0 pounds fish; 4.292 pounds Invertebrates; 71.882 pounds algae/shells
