BACKGROUND

The Statewide Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling Policy or OTC Policy) requires that the Statewide Advisory Committee on Cooling Water Intake Structures (SACCWIS) be convened to ensure that implementation of the OTC Policy will not cause disruption in the State of California's electrical power supply. All meetings of the SACCWIS are open to the public, and the SACCWIS will hear public comment on any items under consideration.

The meeting will include presentation, review, and the opportunity for committee approval of the annual SACCWIS report in accordance with the OTC Policy. The SACCWIS prepares the annual report for the State Water Resources Control Board (State Water Board) to summarize the state's current electrical grid reliability needs and to recommend modifications, if necessary, to the compliance schedule for fossil fuel power plants using ocean water for once-through cooling.


