Funding Sources

- Funding Sources
 - Proposition 40
 - Proposition 50
 - Nonpoint Source (NPS) Implementation Program
(Federal Clean Water Act, Section 319)
- Approximately \$152 million available

Grant Programs

- Coastal NPS Pollution Control Program - \$43.1 M
- NPS Pollution Control Program - \$19 M
- Federal 319 NPS Implementation Program - \$4.5 M
- Agricultural Water Quality Grant Program - \$14
- Urban Storm Water Program - \$14.25 M
- Integrated Watershed Management Program - \$47.5 M
- CALFED Drinking Water Quality Program - \$3.4 M
- CALFED Watershed Program - \$6 M

Prop 50 Coastal Nonpoint Source (CNPS)

- Total of \$43.1 million available
- At least \$10 million for Ocean Protection Projects
- Meet joint Priorities of the State Water Board and the Ocean Protection Council

Prop 50 CNPS Projects

- Maximum grant \$5 million
- Municipalities, Local Public Agencies, educational Institutions, Non-profits eligible
- Match required:
 - 20% for projects \$1-5 million
 - 15% for projects \$125K to \$999,999
 - 10% for projects less than \$125K

Eligible Projects

- Improve water quality at public beaches
- Provide comprehensive capability for monitoring
- Make improvements to sewer collection or septic systems
- Implement stormwater pollution prevention programs
- Consistent with the state's NPS Control Program

Project Requirements

- Demonstrate sustained benefit of 20 years
- Address the cause of degradation
- Consistent with water quality and resource protection plans
- Include monitoring and reporting that:
 - Identifies the NPS pollution
 - Describes baseline water quality
 - Describes how effectiveness demonstrated

Timeline: Projected Dates*

- Draft Guidelines: *September 2005*
- Workshops for Draft Guidelines *October 2005*
- Final Guidelines Adopted *January 2006*
- Concept Proposals Due *February 2006*
- Full Proposal Invitations: *February – March 2006*
- Full Proposals Due: *April 2006*
- Recommended Project Lists *September-November
2006*
