**SUBJECT OF THE CANCELLED HEARING**

The State Water Resources Control Board (State Water Board) scheduled a hearing to receive evidence relevant to determining whether the petition filed by Mr. Charles Grace (Petitioner) seeking review of a Division of Financial Assistance Final Division Decision (FDD) dated December 10, 2009, should be granted.

By Notice of Postponement of Public Hearing, dated July 7, 2011, the State Water Board postponed the August 29, 2011 hearing at the request of Mr. Charles Grace and the State Water Board's Office of Enforcement. On October 12, 2011, the State Water Board's Executive Director issued Water Quality Order WQ 2011-0016-EXEC (Stipulated Order Imposing Operator Certification Discipline). Accordingly, no hearing is required to be held concerning the petition and the previously postponed hearing is cancelled.
