# Wastewater Treatment Plant Operator Examinations

The next Wastewater Treatment Plant (WWTP) Operator examination is April 5, 2014. Calculator Criteria - The criteria for calculator use for the WWTP Operator examination has been revised. The new criterion is as follows:

- Simple electronic calculators that are silent, including non-programmable scientific calculators are allowed.
- Programmable calculators, smart phones, tablets, computers, and calculators with paper printout are not allowed.
- <u>Prohibited</u> programmable calculators include calculators that have alpha keyboards, graphing calculators, large display screens that are capable of displaying worded messages, or calculators that allow for the insertion of preprogrammed cards.
- Please be aware that solar calculators may not function because of lighting conditions.
- It is acceptable to bring an additional simple calculator as a back-up. DON'T TAKE A CHANCE – BRING A SIMPLE ELECTRONIC CALCULATOR AND EXTRA BATTERIES.

# What Will Delay Processing My Application?

#### Certification

- Incomplete, incorrect, or missing application
- Missing or incorrect payment amount
- No original signature(s)
- No Chief Plant Operator (CPO) listed
- Missing current and previous WWTP experience
- No duty statement on official letterhead and/or the duty statement is not signed by the CPO
- Missing high school diploma, GED or equivalent
- Missing continuing education or transcripts

#### Examination

- Incomplete, incorrect, or missing application
- Missing or incorrect payment amount
- No original signature
- Missing high school diploma, GED or equivalent
- Missing continuing education or transcripts

#### Renewal

- Incomplete, incorrect, or missing application
- Missing or incorrect payment amount
- No original signature

Per the regulations, the OOC has up to 30 days to process these applications. Please be patient, as we process on a first-come, first-serve basis.
