APPROVAL OF EXTENSION OF DEADLINES FOR SUBMITTING SITE-SPECIFIC CHROME PLATING WORK PLANS TO DETERMINE THE PRESENCE OF PER- AND POLYFLUOROALKYL SUBSTANCES (PFAS) SUBJECT TO THE OCTOBER 11, 2019 STATE WATER RESOURCES CONTROL BOARD ORDER# WQ 2019-0045-DWQ

This letter serves to approve an additional 60-day extension for submitting Work Plans subject to State Water Resources Control Board's (State Water Board) Order# WQ 2019-0045-DWQ for the Determination of the Presence of Per- and Polyfluoroalkyl Substances (PFAS) at Chrome Plating Facilities, dated October 11, 2019 (Order). This extension is granted to the members listed in five letters dated March 12, 2020 from the Metal Finishing Association of Southern and Northern California (MFASC/MFANC) to the San Francisco, Los Angeles, Central Valley, Santa Ana, and San Diego Regional Water Quality Control Boards (Regional Water Boards). Work Plans must be submitted to the Regional Water Boards no later than May 29, 2020. No further extensions will be granted.

The Order requires 271 suspected chrome plating facilities to submit a questionnaire or a work plan and final sampling and analysis report to the applicable Regional Water Board for a one-time preliminary site investigation of PFAS impacts to soil, groundwater, stormwater runoff, and/or effluent wastewater. The Order allows a time extension for good cause.

#### Background

The State Water Board issued a letter on November 22, 2019 approving an extension to the due dates for submitting the questionnaires to January 24, 2020 and the Work Plans to March 31, 2020. MFASC/MFANC requested the extension to allow facilities to conduct further reviews to complete the questionnaire accurately, to allow for additional time for the MFASC/MFANC to develop a "model work plan" and to provide time to understand the Order requirements. The State Water Board met with MFASC/MFANC from December 2019 through February 2020 to provide clarifications to the Order requirements and to answer questions. During this process, the MFASC/MFANC developed a Work Plan template and Sampling and Analysis Plan and distributed them to their members in late February 2020.

On March 12, 2020, MFASC/MFANC submitted a letter requesting an additional 120- day extension to the compliance deadlines for the Work Plan for their member facilities. This extension request states that their member facilities need additional time to comply with the Order because consultants are backlogged with other obligations, consultant fees are more expensive than anticipated, and each facility needs more time to complete the procurement process to vet viable consultants for the work. MFASC/MFANC also stated that the situation is exacerbated by the recent and growing challenges the businesses are now facing with Coronavirus 2019 [COVID-19].

The new due date for Work Plans to be submitted to the Regional Board is extended to May 29, 2020. As stated above, no further extensions will be granted.
