# NOTICE OF STAFF WORKSHOPS

### NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM GENERAL PERMIT FOR STORM WATER DISCHARGES FROM SMALL MUNICIPAL SEPARATE STORM SEWER SYSTEMS REVISED DRAFT TENTATIVE ORDER

The State Water Resources Control Board (State Water Board) will hold five (5) staff workshops to address questions the public may have about the Revised Draft National Pollutant Discharge Elimination System General Permit for Storm Water Discharges from Small Municipal Separate Storm Sewer Systems (Revised Draft Tentative Order). These informational workshops are NOT public hearings for the Revised Draft Tentative Order. Although a quorum of the State Water Board may be present at a staff workshop, the State Water Board will not take any action during any staff workshop.
