APPENDIX V

COMMENTS ON THE DRAFT

EIR/EIS

The City of Santa Rosa conducted a 65-day public comment period from July 31 until October 7, 1996, during which time 14 agencies and 119 individuals or organizations commented on the document. On September 24, 1996, a public hearing was held at which 67 speakers commented on the Draft EIR/EIS.

The City of Santa Rosa, acting on behalf of both the U.S. Army Corps of Engineers and itself, received 138 comment letters during the 65-day public comment period. Several letters were received more than once (e.g., faxed and mailed). If the letters are exactly the same, they were treated as one letter; if they differed even slightly in substance, we have treated them as two separate letters.

Comment letters are included in Volumes XVIII and XIX. A verbatim transcript of the public hearing comments, as produced by a court reporter, is also included in Volume XIX.

A list of the type of commentor is presented in Table V-1 and the list of commentors is presented in Tables V-2, V-3, and V-4. Letters received within the circulation period were assigned a number in the 100 series. Oral comments received at the public hearing were assigned a number in the 200 series and letters received after the official circulation period was closed were assigned a number in the 300 series.
