

6.3 RESPONSES TO COMMENTS (COMMENT LETTERS 1 THROUGH 85)

Section 6.3 contains the responses to both written and oral comments, received by the City of Santa Rosa during the 65-day public comment period (from August 31, 1996 to October 7, 1996) on the Draft EIR/EIS for the Santa Rosa Subregional Long-Term Wastewater Project.
