# NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC MEETING

## PROPOSED CLEAN WATER ACT SECTION 303(d) LIST OF WATER QUALITY LIMITED SEGMENTS PORTION OF THE 2012 CALIFORNIA INTEGRATED REPORT

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will accept comments on the proposed federal Clean Water Act (CWA) section 303(d) list of water quality limited segments (303(d) List) portion of the 2012 California Integrated Report. The 2012 California Integrated Report includes the CWA section 305(b) report of surface water quality (305(b) Report). Only the 303(d) List portion of the California Integrated Report requires approval by the State Water Board and U.S. EPA. Neither agency approves the 305(b) Report portion of the California Integrated Report.

### BACKGROUND

The proposed 303(d) List portion of the 2012 California Integrated Report is a compilation of the 303(d) Lists from the Regional Water Quality Control Boards (Regional Water Boards) for the North Coast, Lahontan, and Colorado River regions. In addition, the proposed 303(d) List includes State Water Board staff recommendations for additions, deletions, or changes to the 303(d) Lists from those three regions. Regional Water Board staff held stakeholder meetings in their respective regions and provided advance notice and opportunity for public comment prior to approval of their 303(d) Lists. After the State Water Board approves the 303(d) List, the 2012 California Integrated Report will be submitted to U.S. EPA. U.S. EPA may make changes to the 303(d) List which is only effective upon U.S. EPA's approval.

### CALIFORNIA ENVIRONMENTAL QUALITY ACT

The State Water Board's approval of the 303(d) List is not a "project" subject to the California Environmental Quality Act because such action has no potential to result in a "direct physical change in the environment, or a reasonably foreseeable indirect physical change on the environment" (Pub. Res. Code § 21065). The 303(d) List satisfies reporting requirements of the CWA and provides information for setting priorities for future actions.
