

Water Boards' Strategic Plan

- Adopted September 2, 2008
- "Promote Sustainable Local Water Supplies":
 - "Increase sustainable local water supplies ... by 1,725,000 acre-feet per year, in excess of 2002 levels, by 2015, and ensure adequate flows for fish and wildlife habitat."

Water Boards' Strategic Plan

Conservation actions:

- Update urban best management practices and agricultural efficient water management practices
- Ensure effective implementation of water demand management measures with funding criteria & take actions to limit waste and unreasonable use
- Validate water conservation terms in water right permits

Bay-Delta Workplan

Adopted July 16, 2008
 Water Use Efficiency Element
 Addresses 4 specific conservation activities

Proposes policy to require wastewater permittees to plan for and implement water recycling

Bay-Delta Workplan

Specific Water Conservation Activities
Adopt regulations to require implementation of certain BMPs
Conduct adjudicative proceedings for 2 areas or suppliers to prevent waste or unreasonable use
Work with 20x2020 Agency Team

 Evaluate feasibility of coordinated water measurement database

CUWCC MOU

- Adopted September 1991
- Initiated as a voluntary effort in lieu of State Water Board Bay-Delta proceedings as evidence of water conservation commitment
- 14 urban BMPs
- Annual reports to State Water Board

Delta Vision Blue Ribbon Task Force & Strategic Plan

- November 30, 2007 Task Force Report
- September 2008 Draft Strategic Plan
- Both have strong statements on conservation, e.g.,

 "The goals of conservation, efficiency, and sustainable use must drive California water policies."

California Water Plan Update

- Last update 2005, next 2009
- Chapters on urban and agricultural water conservation
- Update 2005: of 8 water management strategies, urban water use efficiency had highest potential

"20x2020" Water Conservation Goal

- Governor's letter to State Senate February 2008
 - 7 Actions to fix Delta
 - Ist Action: Goal to reduce per capita water use 20% by 2020

20x2020 Agency Team

Strategic Implementation Plan early 2009

20x2020 Agency Team

DWR & SWRCB Co-chairs
6 State agencies, 1 federal
CUWCC

Broad Water Board Authority

- Calif Constitution, Art. 10 & Water Code §100:
 - Right to water does not extend to waste or unreasonable use

 Water Code §275:
 DWR & SWRCB shall take all appropriate action to prevent waste

Legislation

- AB 1420 (2007) state funding for water management contingent on conservation implementation
- AB 1881 (2006) DWR to update model landscape ordinance by Jan 2009, cities & counties required to adopt

Legislation

- AB 32 Greenhouse Gas Reduction
 - Scoping Report Adoption due Dec 2008
 - Conservation is key water GHG element
 - Recommends public goods charge on water to fund conservation & other water efficiency and GHG projects

Sampling of Comment Letters

- Existing voluntary processes or legal mandates sufficient
- Adopt performance-based mandate with flexibility or adopt specific BMPs
- Mandate/don't mandate pricing structures

Sampling of Comment Letters

- Delay until 20x2020 recommendations
- Delay until revised BMPs and AB1420 take effect
- Target enforcement on agencies without effective conservation programs
