D E C R E E

8 This matter came on regularly for hearing before the above entitled
9 court, sitting without a jury, on the 29th day of November 1921, pursuant to
10 the provisions of the Water Commission Act of California and upon the "Order of
11 Determining and Establishing the Several Rights by Appropriation of the Waters
12 of the West Fork of Carson River and its Tributaries in Alpine County, Calif-
13 ornia" made and entered by the State Water Commission of California on the
14 20th day of July 1921, the original evidence and transcript of testimony filed
15 with or taken before the said Water Commission duly certified by it and filed
16 herein, and the exceptions to the aforesaid order filed herein by W. F. Dressler,
17 and the K. H. Springmeyer Land Development and Livestock Co., a corporation,
18 respectively. The Division of Water Rights, Department of Public Works, State
19 of California, being the successor of said State Water Commission, and the said
20 exceptors being duly represented in court by their respective attorneys, oral
21 and documentary evidence was introduced and the matter being submitted to the
22 court and the court being fully advised in the premises and having made and
23 signed its findings of fact herein, it is hereby

24 ORDERED, ADJUDGED and DECREED, that

25 1. The descriptions of the points of diversion and areas irrigated
26 referred to herein are as determined by the survey made by the State Water Com-
27 mission of California in May and June, 1920, except those descriptions contained
28 in paragraphs 44 and 45 of this order which were prepared from data supplied by
29 claimants.

30 2. The point of measurement of all allotments herein made shall be
31 at the respective points of diversion from the stream.

3. At all times when users are prevented from diverting a contin-
uous flow, by the provisions of the decree in the case of Anderson et al. vs.

1 Bassman et al., No. 12,857, in the Circuit Court of the United States, Ninth
2 Circuit, all users shall be entitled to divert double the continuous flow
3 allotments hereinafter set forth during the weeks in which the California
4 users are entitled to divert and use water from the West Fork of Carson River
5 as set forth in Clause No. 7 of the above mentioned decree, except those allot-
6 ments diverted through the Panning, Snowshoe Thompson No. 1, Snowshoe Thompson
7 No. 2, Millich, and Wade ditches.

8 4. At all times when W. F. Dressler is prevented from diverting a
9 continuous flow through the Panning ditch, by the provisions contained in
10 Clause No. 12 of the decree in the said case of Anderson et al. vs. Bassman et
11 al., he shall be entitled to divert $3\frac{1}{2}$ times the continuous flow allowance here-
12 inafter allotted to him through said ditch, on those days when he is entitled
13 by the above mentioned decree to divert water.

14 5. At no time shall those users who are entitled to divert water
15 through the Snowshoe Thompson No. 1, Snowshoe Thompson No. 2, Millich, and
16 Wade ditches divert amounts in excess of the continuous flow allotments here-
17 inafter set forth for those ditches, for use for the purposes hereinafter set
18 forth.

19 6. The following parties, Dick Wenshold, Margaret Chambers, Truckee
20 River General Electric Company, Richard Heimsoth, Herman Gansberg, Mrs. M.
21 Merrill, Hans Johnson and Joseph Scossa are entitled to divert from the natural
22 flow of the West Fork of Carson River, into their ditches at the respective
23 points of diversion hereinafter set forth, sufficient water for stock watering
24 and domestic purposes, to keep their fire tanks full, and to preserve their
25 flumes, at all times.

26 Subject to the foregoing general provisions the several claimants
27 to the use of water of said stream are entitled to divert and use such water as
28 follows:
