for Failure to Submit Information of Water Diversion and Use by

(DUTCH BILL CREEK WATERSHED)**

BY THE ASSISTANT DEPUTY DIRECTOR FOR WATER RIGHTS¹

The Assistant Deputy Director for the Division of Water Rights of the State Water Resources Control Board (State Water Board) issued an [Administrative Civil Liability Complaint](#) (Complaint) to the parties listed in Attachment A (collectively "Parties") for failure to fulfill obligations under State Water Board Order WR 2015-0026-DWR² on December 15, 2015. Between December 17, 2015 and January 11, 2016, the Parties signed the Acceptance of Conditional Settlement Offer and Waiver of Right to Hearing and Reconsideration (Conditional Settlement). Between December 15, 2015 and January 19, 2016, the Parties submitted water use and supply information to the State Water Board.

The circumstances here support accepting the Conditional Settlement, as the State Water Board has received the water use and supply information and the signed Conditional Settlement.

I hereby approve the Conditional Settlement pursuant to my delegated authority. This approval shall not limit the authority of the Executive Director or the Deputy Director for Water Rights, as delegated, to initiate enforcement action for any violations not specified in the Complaint, or for violation of the terms of the Conditional Settlement.

The Deputy Director for Water Rights has redelegated this authority to the Assistant Deputy Director for Water Rights pursuant to State Water Board Resolution 2012-0029.
