Notice is hereby given that Fetzer Vineyards filed petitions for the above licensed applications. The State Water Resources Control Board (State Water Board) will determine whether an order approving the change should be issued for licensed applications, if so, whether conditions are needed in the licenses to protect the environment, the public interest, and downstream water users. This notice provides a description of the project and also describes the procedure and time frame for submittal of protests against the petitions. Description of Project: In 2001, Division staff found there are no fixed diversion sites and the place of use (POU) were changed without approval by the State Water Board, thereby necessitating the listed petitions for change. The Fetzer Vineyards' diversion pump sites, conveyance and irrigation systems, and acreage for the places of use to utilize water as authorized under the licenses are summarized below.

PETITION SUMMARY:

Fetzer Vineyards' petitions seek approval by the State Water Board to amend their seven licenses to re-designate the places of use for each water right as currently operated, and to have APP-NOT (3-03) moveable points of diversion (MPOD) to directly divert Russian River flows primarily for irrigation of vineyards. The proposal is to replace the fixed points of diversion with MPOD along the east bank of the Russian River with a defined upper and lower limit. The following are the changes petitioned by Fetzer Vineyards as shown on maps on file with the State Water Board.

For Licenses 9597, 9598, 9613, and 9823; the upper reach of the MPOD is within the SW¹/₄ of NE¹/₄ of projected section 7, T13N, R11W, MDB&M. The lower reach is within the SW¹/₄ of NE¹/₄ of projected section 19, T13N, R11W, MDB&M. Approximately three miles of river frontage would be allowed to have portable diversion pump(s) be placed.

For Licenses 9614, 9602, and 9604; the upper reach of the MPOD is within the NE¹/₄ of NE¹/₄ of projected section 19, T13N, R11W, MDB&M. The lower reach is within the SW¹/₄ of NE¹/₄ of projected section 19, T13N, R11W, MDB&M. Approximately a half-mile of river frontage would be allowed to have portable diversion pump(s) be placed.

Fetzer Vineyards would set the total amount of water taken under Licenses 9614, 9602, and 9604 not to exceed 95 af per year.

Environmental Information

The lead agency will prepare the appropriate environmental documents for the project according to the California Environmental Quality Act (CEQA) and its guidelines, and will determine whether or not the project will cause a significant effect on the environment. If you are not filing a protest, but wish to submit information that indicates the project may cause a significant effect on the environment, please send this information to Steven Herrera; State Water Board, Division of Water Rights; P.O. Box 2000; Sacramento, CA 95812-2000. This information will be reviewed in accordance with CEQA.

PROTEST SUBMITTAL INFORMATION

Protest Requirements

A person may file a protest based on any of the following factors:

- Interference with prior water rights.
- Adverse environmental impact.
- Not in the public interest.
- Contrary to law.
- Not within the jurisdiction of the State Water Board.

All protests must clearly describe the objections to approval of the petition, and the factual basis for those objections. For example, if the objection is based on injury to existing water rights, the protest must describe the specific injury to the existing water right that would result from approval of the changes proposed by the petition. In addition, the party claiming injury to prior water rights must provide specific information that describes the basis of the existing right, the

date the use began, the quantity of water use, the purpose of use, and the place of use. Protests based on environmental impacts, public interest, legality, or jurisdictional issues must be accompanied by a statement of facts supporting the basis of the protest. If sufficient information is not submitted, the State Water Board may reject the protest or request that the protestant submit additional information. Protests of a general nature (not project specific) or protests that are inconsistent with constitutional or legislated state policy will not be accepted. A request for information or a request that studies be conducted does not constitute a protest. **The Division will not accept protests that are directed against the underlying water right, rather than the change proposed by the petition.**

Procedure for Submitting Protests

Protests should be submitted on standard protest forms available from the Division's website at <u>www.waterboards.ca.gov/forms/</u> or upon request from the Division. A pamphlet that provides additional information relating to water rights and the procedure for filing protests is also available on the website or by mail. Any requests or the

submittal of the completed protest form should be directed to the engineer listed as the contact person at the end of this notice. A copy of the completed protest form must also be mailed to the petitioner and should include a description of any measures that could be taken to resolve the protest.

Protest Submittal Deadline

Protests submitted in response to this notice must be received by the Division by 3:00 p.m. on the

 30^{th} day after the date of this notice (the close of the protest period). Protests may be submitted by any of the following methods:

f you choose to fax or e-mail the protest due to the constraints of the noticing period, the fax or e-mail must be followed by timely delivery of an original signed copy, either personally or by mail, to the Division in order for the protest to be accepted. The State Water Board will respond to all protests within 60 days of the final day to file a protest. **Protests not submitted by the close of the protest period will be subject to rejection.**

For good cause, the State Water Board may grant an extension of time to file a protest. It is the protestant's responsibility to contact the engineer listed below as "Contact Person" to request the extension prior to the end of the protest period.

Resolution of Protests

The petitioners will have 30 days to respond to a protest once it is accepted by the Division. The protestant and the applicant are expected to make a good faith effort to resolve the protest within 180 days from the close of the protest period.
