- The amount shown for O'Neill Lake is for refill after exercise of Camp Pendleton's pre-1914 appropriative right.
- Total amount to be diverted to underground storage under Permits 8511, 11357, and 15000 includes estimated amount recharged to the underground basin due to induced infiltration.
- Total amounts do not include Camp Pendleton's riparian right or the direct diversion component of the Petitions for Change for the subject Permits.
- Individual rights are constrained by amount, rate and season. Therefore, rows and columns are not necessarily additive. Totals shown are in the aggregate and exclude direct diversion amounts.
