- · GIVE REASON FOR PROPOSED CHANGE: Realign water right to benefit Park mission, including enhancing fish and wildlife habitat, and recreation.
- WILL THE OLD POINT OF DIVERSION OR PLACE OF USE BE ABANDONED? Yes. There are three Points of Diversion for this water right. Prior owner of this right—Waldo Giacomini and his successors—maintained an intake on Marin County parcel 119-240-67 for use on parcel 119-04-26. Following SWRCB Decision 95-17 which determined that the seasonal summer dam erected to maintain this water right affected coho salmon and steelhead trout, an upstream point of diversion was added. This point of diversion on Lagunitas Creek was from a surface flow influenced well (Downey Well) operated by North Marin Water District. The original structures associated with the original surface point of diversion (APN 119-240-67) were removed as part of the Giacomini Wetlands Restoration Project. The North Marin Water District is currently evaluating closure of the Downey Well through a separate CEQA process.
- WATER WILL BE USED FOR Enhancement of fish and wildlife habitat pursuant to Section 1707. We are seeking to change the entire licensed amount of 2.00 cfs.

#### Attachment No. 1

The National Park Service (NPS) acquired this water right in conjunction with land purchased from Waldo Giacomini. License No. 4324 was divided between Waldo Giacomini and his successors and the North Marin Water District prior to the time of purchase. At the time of purchase, the National Park Service received License 4324A (2.00 cfs). The North Marin Water District maintains License 4324B (0.67 cfs).

The grantor of the land and water right, Waldo Giacomini, reserved the right to continue use of this License No. 4324A through August 2007 in support of his dairy and cattle operation. Diversion of water pursuant to this License ceased August 2007; thereafter the water was allowed to remain in the stream.

NPS desires to change the use of this License pursuant to Section 1707. Most of the land acquired from Mr. Giacomini has been restored to active floodplain or wetlands as part of the Giacomini Wetland Restoration Project. The impacts of this Project are addressed in the *Final Giacomini Wetland Restoration Project Environmental Impact Statement/Environmental Impact Report* (2007). The conversion of License 4324A to instream flow was identified in the Giacomini EIS/EIR. The National Park Service Record of Decision for the Giacomini Wetland Restoration was signed August 16, 2007. The California State Lands Commission, the lead CEQA agency, voted to certify the EIR on June 28, 2007. The Notice of Determination was filed at the California State Clearing House on July 9, 2007.

There will be no construction or re-grading as a result of this petition. All physical work, including removing of diversion structures, was completed during the fall of 2008 as part of the Giacomini Wetland Restoration.


