## NOTICE OF PETITION FOR CHANGE FOR PERMIT 16584 (APPLICATION 18733)

COUNTY: Madera

STREAM SYSTEM: Fresno River

The U.S. Bureau of Reclamation has filed a Petition for Change seeking to add 15 points of rediversion on Cottonwood Creek within the boundaries of Madera Irrigation District to its permit for Hidden Dam/Hensley Lake Reservoir. If the petition is granted, a license will be issued that includes the all of the points of rediversion currently used by Madera Irrigation District for conveyance of project water.
