Attachment No. 1 Petition for Change to License 904 (Application 1199) held by Conaway Preservation Group

GENERAL

The purpose of this Petition for Change (Petition) is to split Conaway Preservation Group's (CPG) License 904 (Application 1199) into two licenses in accordance with the Agreement between CPG and the Woodland-Davis Clean Water Agency (Agency) dated December 15, 2010 (Agreement) – License 904A (Application 1199A) for the Agency, and License 904B (Application 1199B) for CPG. The Agreement also provides that CPG's License 5487 (Application 12073) is to be split between CPG and the Agency–License 5487A (Application 12073A) for the Agency, and License 5487B (Application 12073B) for CPG; and thus, a separate petition for change will be filed with the Division of Water Rights (Division) for this purpose. The split of these licenses will result in a source of water supply for use by the Agency when the diversion prohibition in Term 91 is in effect, in accordance with the State Water Resources Control Board's (State Water Board) Decision adopted on March 1, 2011. The changes proposed to CPG's licenses are in conformance with the Agreement between the Agency and CPG; and also, in conformance with the Agency's Application 30358 and the State Water Board's Decision. These changes involve the split of Licenses 904 and 5487 and additions to the purposes of use, point of diversion, and place of use. No other changes to Licenses 904 and 5487 are proposed. Together, the portions of Licenses 904 and 5487 proposed to be held by the Agency in the form of new licenses will authorize direct diversions from the Sacramento River at a rate of up to 80 cfs during about April 1 through about October 31 for the proposed purposes and places of use described in this Petition and the petition for change to License 5487. CPG will retain the remaining portions of Licenses 904 and 5487 in the form of new licenses, as identified below.

Specifically, as provided for under the Agreement, the Agency's License 904A will identify: (1) a maximum authorized monthly average direct diversion rate of 80 cfs, with a maximum instantaneous diversion rate of 100 cfs, from about April 1 through about September 30; (2) the total maximum authorized annual diversions under Licenses 904A and 5487A will be 10,000 AF/yr; (3) the total maximum authorized diversions under License 904A during about July 1 through about September 30 of each year will be 7,500 AF; (4) additional point of diversion (with subsequent deletion of existing point of diversion); (5) municipal, industrial, irrigation, fish and wildlife enhancement, and fisheries and aquaculture research as authorized purposes of use; and (6) authorized places of use for both the proposed Davis-Woodland Water Supply Project service area (which is specified as the authorized place of use in the Agency's Application 30358) and CPG's present place of use covered by License 904.

CPG's License 904B will, as provided for under the Agreement, include: (1) all rights under License 904 that are not in License 904A; (2) additional point of diversion (with subsequent deletion of existing point of diversion); and (3) the addition of fish and wildlife enhancement as a purpose of use in addition to the existing use of irrigation.

In addition to the above, as provided for under the Agreement, the Agency's License 904A and CPG's License 904B will both specify: (1) priorities of CPG's Licenses 904B and 5487B and CPG's Licenses 905 (Application 1588) are junior to priorities of Licenses 904A and 5487A as long as water used under Licenses 904A and 5487A are for municipal and industrial uses within the Agency's place of use; (2) a provision that for any uses by the Agency besides municipal and industrial uses within the Agency's place of use, Licenses 904A and 904B will have equal priorities and Licenses 5487A and 5487B will have equal priorities; (3) the maximum seasonal quantity of water to be directly diverted pursuant to Licenses 904A, 904B, 905, 5487A, and 5487B and Central Valley Project water entitlements under licensees' Sacramento River Settlement Contracts with the U.S. Bureau of Reclamation shall not exceed 50,862 acre-feet during the period from about April 1 through about October 31 during the term of those contracts or any renewals thereof, and for an amount not to exceed 94,400 acre-feet during the period from about April 1 through about October 31, if those contracts are not in place; and, (4) no other substantive changes from License 904 to Licenses 904A and 904B. No changes are proposed for CPG's License 905.

CPG's Licenses 904, 905, and 5487 are the basis for the quantities identified in CPG's Sacramento River Settlement Contract (Settlement Contract) with the U.S. Bureau of Reclamation (Reclamation). In accordance with the Agreement, CPG's Settlement Contract will be split into two Settlement Contracts, one assigned to the Agency and the other assigned to CPG, for conformance with the split of Licenses 904 and 5487. Diversions under Licenses 904A, 904B, 905, 5487A, and 5487B will be undertaken consistent with the Settlement Contracts.

POINT OF DIVERSION OR REDIVERSION

Present and Proposed Points of Diversion

The present point of diversion from the Sacramento River will not change within the next few years. During this period, it is expected that a new pumping facility and fish screen will be constructed within a few hundred feet downstream of the present point of diversion. Following construction and operation of this new facility, which is identified as a point of diversion in the Agency's Application 30358, the existing facility will be abandoned. Thus, the present point of diversion under License 904 will continue to be relied upon for diversions under proposed Licenses 904A and 904B until the new facility and fish screen are complete. No diversions to the Agency will occur until the new facility and fish screen are complete and operational. The Division will be notified of the completion and operation of this new facility. Therefore, CPG proposes to include the new facility as an additional point of diversion to Licenses 904A and 904B for diversions from the Sacramento River.

The present point of diversion will be used during the next several years for direct diversions under Licenses 904A and 904B. The map identifying this point of diversion for Licenses 904A and 904B is the existing map for License 904 contained in the Division's files. The present point of diversion is currently described as follows:

PLACE OF USE

Present Place of Use

The present place of use covered by License 904 includes irrigation of 21,314 acres within T9N and 10N, R2E and 3E, MDB&M, as shown on a map received by the Division on February 17, 1920.

Proposed Places of Use

The proposed place of use for the Agency's License 904A is the present place of use covered by License 904 and an additional place of use including 23,950 acres shown on the map for the Agency's Application 30358. The map identifying the proposed place of use for License 904A is the existing map for License 904 and the existing map for Application 30358. See the Division's files for copies of these maps and for lists of assessor's parcel numbers associated with the existing place of use for License 904 and the place of use for Application 30358. The proposed place of use for License 904A is described as follows:

Municipal and Industrial uses within T8N, R1E, and T8N, 9N, 10N, R2E and 3E, MDB&M;

Irrigation uses within 23,950 acres located within T8N, R1E, and T8N, 9N, 10N, R2E and 3E, MDB&M;

Irrigation and Fish and Wildlife Enhancement uses within 21,314 acres located within T9N and 10N, R2E and 3E, MDB&M; and,

Fisheries and Aquaculture Research uses within Sections 16 and 21, T8N, R2E, MDB&M.

The proposed place of use for CPG's License 904B is the present place of use covered by License 904. The map identifying the proposed place of use for License 904B is the existing map for License 904. See the Division's files for a copy of this map and for a list of assessor's parcel numbers associated with the existing place of use for License 904. The proposed place of use for License 904B is described as follows:

Irrigation and Fish and Wildlife Enhancement uses within 21,314 acres located within T9N and 10N, R2E and 3E, MDB&M.

PURPOSE OF USE

Present Purpose of Use

The purpose of use presently authorized by License 904 is Irrigation.

Proposed Purposes of Use

The proposed purposes of use for the Agency's License 904A include Municipal, Industrial, Fish and Wildlife Enhancement, Fisheries and Aquaculture Research, and the presently authorized purpose of Irrigation. The proposed purposes of use for CPG's License 904B include Fish and Wildlife Enhancement and the presently authorized purpose of Irrigation.

GIVE REASON FOR PROPOSED CHANGE

The changes identified in this Petition are proposed as a result of the Agreement between CPG and the Agency in order to meet the condition of the State Water Board's Decision, adopted on March 1, 2011, that the Agency demonstrate a dependable alternate source of water supply for use by the Agency when the diversion prohibition in Term 91 is in effect and prohibits diversions from the Sacramento River under the permit issued upon the Agency's Application 30358. Based on discussions with the Agency, approval of this Petition would authorize the Agency's diversion and use of a water supply that meets a portion of the Agency's demand when the diversion prohibition in Term 91 is in effect.

This Petition requests to divide CPG's License 904 into License 904A for the Agency and into License 904B for CPG. License 904A would provide the Agency with a reliable surface water supply from the Sacramento River during periods when Term 91 prohibits diversions under the permit issued upon the Agency's Application 30358. This Petition is being filed in advance of completing construction of the new pumping facility and fish screen for diversions from the Sacramento River under the Agency's Application 30358. Diversions at the existing pumping facility will continue under proposed Licenses 904A and 904B for use within the existing place of use for License 904 until such time that the new facility is complete. Thereafter, diversions will occur at the new facility under License 904A, with the flexibility to deliver and use surface water upon the existing place of use covered by License 904 and the proposed additional place of use for the Agency. In addition, diversions will occur at the new facility under License 904B for the use of surface water upon the existing place of use covered by License 904. These proposed changes are in conformance with the Agreement between the Agency and CPG; and also, in conformance with the Agency's Application 30358 and the State Water Board's Decision.

ABANDONMENT OF POINT OF DIVERSION

As previously identified in this Petition, the present point of diversion under License 904 will continue to be relied upon for diversions under proposed Licenses 904A and 904B until the new facility and fish screen are complete. No diversions to the Agency will occur until the new facility and fish screen are complete. Until that time, diversions from the Sacramento River will be used upon the existing place of use for License 904, approximately 24,314 acres, which is proposed to be included in Licenses 904A and 904B. Following construction of this new facility, which will be located within a few hundred feet downstream of the present point of diversion, the existing facility will be abandoned. At that time, the Division will be informed of the completion and operation of the new facility and the proposed deletion of the present point of diversion from the licenses.

OWNERSHIP AND ACCESS

CPG intends to convey to the Agency and Reclamation District No. 2035 (RD 2035) the property on which the Agency and RD 2035 will construct a new, screened diversion facility. The property will be owned by the Agency and RD 2035 as tenants in common, with the Agency holding a 20% interest and RD 2035 holding an 80% interest in the property. As such, under proposed License 904A, access to the place of use for the delivery of surface water will be by virtue of ownership of the property on which the diversion facility is located, or via the conveyance system, or as a condition of service to the Agency's customers in accordance with its rules and regulations, including the Agreement between CPG and the Agency. Under proposed License 904B, access to the place of use for the delivery of surface water is by virtue of ownership of the conveyance system and land, or as a condition of service to CPG's customers in accordance with its rules and regulations.
