NOTICE OF PETITION FOR CHANGE FOR WATER RIGHT LICENSES 588 AND 4386 (APPLICATIONS 3421 AND 14624) OF ORSI FAMILY TRUST

COUNTY: Mendocino

STREAM SYSTEM: RUSSIAN RIVER

On December 19, 2019, Orsi Family Trust (Petitioner) filed petitions to change its water right Licenses 588 and 4386 (Applications 3421 and 14624) with the State Water Resources Control Board, Division of Water Rights (Division) pursuant to Water Code section 1701. The Petitioner has requested to modify the authorized points of diversion and places of use under the two licenses.

License 588 currently allows Petitioner to directly divert up to 0.56 cubic foot per second from three points of diversion along the Russian River from June 1 to September 15 of each year for irrigation use.

License 4386 authorizes the direct diversion of 0.38 cubic foot per second from a point of diversion along the Russian River from May 15 to October 1 of each year for irrigation use.

Petitioners are recent owners of the property and are petitioning to change the authorized points of diversion and places of use to conform to how the property was developed by the previous owners. Petitioner wishes to consolidate property that was severed during the construction of US Highway 101 and is no longer part of the ranch, as well as add currently developed orchard and vineyard to the authorized place of use to conform to present day use. Proposed changes to Licenses 588 and 4386 are summarized below.

- (3) North 2,172,607 feet and East 6,223,381 feet, California Coordinate System, NAD83, Zone 2, being within NW¼ of NW¼ of Section 33, T15, R12W, MDB&M.
