
PCWA and SSWD are petitioning to add points of diversion, points of redirection and places of use to both Permit No. 13856 (App. No. 18085) and Permit No. 13858 (App. No. 18087) for the purpose of transferring a total of 12,000 acre-feet of water through groundwater substitution to the Department of Water Resources' 2009 Drought Water Bank. As you are aware, the Governor proclaimed a drought emergency on February 27, 2009 and requested in paragraph 3 of his proclamation that the State Water Board and DWR expedite the processing of water transfers and related drought mitigation measures. Your staff's prompt attention to and cooperation in processing the attached petitions would be appreciated.
