### SACRAMENTO RIVER RANCH'S PETITION TO AUTHORIZE THE TRANSFER OF WATER TO THE DROUGHT WATER BANK

On November 13, 2008, the Division of Water Rights (Division) received your petition for temporary change to authorize the transfer of up to 2,842 acre-feet (af) of water to the Drought Water Bank under water right License 9995 (Application 4901). Included with the petition was a check in the sum of \$100.00 for State Water Resources Control Board (State Water Board) fees.

In accordance with the California Code of Regulations, Title 23, Division 3, section 1064, the State Water Board fee for a petition for temporary change under one water right license requesting a transfer total of 2,842 af is \$2,849.60. The following additional fee is required to process your petition:

Total State Water Board Fees submitted with the petition	\$100.00

Section 10005 of the Public Resources Code requires the California Department of Fish and Game to impose an \$850.00 filing fee on any user of water who files a petition with the State Water Resources Control Board.

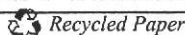
