Requested Change

The United States Bureau of Reclamation (Reclamation) requests that the State Water Resources Control Board (SWRCB) modify the permits and licenses listed in this petition to temporarily change the authorized place of use for municipal and industrial (M&I) purposes of the above Reclamation permits and license to include a portion of the State Water Project (SWP) authorized place of use downstream of the Harvey Banks Pumping Plants as shown on the maps attached to this petition.

Reclamation requests that the above change for the purpose of water exchanges remain in effect for one year from the date of approval under the provisions of Water Code section 1725. The changes are being requested to facilitate water exchanges between Arvin-Edison Water Storage District (a CVP contractor) and Metropolitan Water District of Southern California (a SWP contractor). Metropolitan Water District of Southern California (MWDSC) has previously banked, and continues to bank, its SWP water with Arvin-Edison Water Storage District (AEWSD) under an existing program of groundwater banking and water management. This petition would increase the flexibility of AEWSD to return the banked water to MWDSC. Additionally, the requested change would be used to allow AEWSD to deliver CVP water to MWDSC during wet periods and receive SWP water back in exchange at a later time to facilitate the use of CVP water supplies by AEWSD that have a limited opportunity for use under current CVP operations.

All other provisions of the above permits and license, as modified in accordance with previous petitions¹ submitted by Reclamation to and previously granted by the SWRCB, would remain in effect.

Reason for Requested Change

Currently, California is experiencing unprecedented water management challenges propagated by four years of consecutive drought followed by one of the wettest years of record. Both the SWP and Central Valley Project (CVP) have gone from forecasting low storage conditions in all major reservoirs to all major reservoirs being at or very near full capacity. While the recent drought may be over, the need to strategically and effectively manage these highly variable water resources remains.

If requested by MWDSC, AEWSD is obligated to return banked SWP water to MWDSC within a one year period under their existing program of groundwater banking. Additionally AEWSD is interested in taking advantage of MWDSC's ability to take delivery of and use AEWSD's CVP supplies and return SWP supplies at a future time in order to facilitate AEWSD's ability to match grower demands with CVP water availability. The SWP place of use already includes both MWDSC and AEWSD and thus a change in the SWP place of use is not needed.

The temporary expansion of Reclamation's place of use would allow either Delta CVP or Friant Division water supplies to be delivered into the MWDSC service area. Delivered surface water to MWDSC will be either water previously stored in San Luis Reservoir (San Joaquin River releases recovered and exchanged at Mendota Pool under the San Joaquin River Restoration Program (SJRRP) operations, under a separate petition), or contracted supplies scheduled for delivery to AEWSD from Millerton Lake.

Currently, previously banked SWP water must be recovered from AEWSD banking facilities via groundwater extraction and then delivered to MWDSC. In return for previously banked MWDSC SWP supplies, AEWSD proposes to forego a quantity of its contracted surface water supply (equivalent to MWDSC delivered surface water delivery) and use the groundwater previously banked by MWDSC. The ability to return CVP water pursuant to a temporary change in place of use, in exchange for a like amount of banked SWP water, would enhance the return quantity, timing, and water quality.

This change also allows AEWSD to potentially use more of its existing CVP water by shifting the timing of availability of its CVP supplies to better match up with District grower demands, thereby supplementing surface deliveries to AEWSD water users which results in decreasing the need to directly recharge and subsequently extract supplemental groundwater.

The benefits of this proposed change could also help to offset the impacts to AEWSD of the San Joaquin River Settlement by increasing AEWSD's ability to use wet year water supplies and by increasing the opportunities to complete the return of SJRRP releases to AEWSD (and potentially other Friant Division contractors).

This change would facilitate a "bucket for bucket" exchange and be limited to 100,000 acre-feet of CVP water over its term.

No Injury to Other Legal Users or the Environment

The change requested by Reclamation will not result in unreasonable impacts to fish and wildlife or the environment and will not result in injury to legal users of water.

This petition will not result in any increase in water appropriated by the CVP. Instead, this petition, if approved, would provide the CVP with more flexibility to deliver water to its contractors in a more efficient manner. All water exported at the SWP and CVP pumping plants will continue to be pumped consistent with the criteria and protective measures contained in D1641, the biological opinions for the protection of Sacramento River Winter-run Chinook salmon, Delta smelt, spring-run Chinook salmon, and steelhead. Approval of Reclamation's petition for a temporary change to place of use will not affect

the compliance with the water quality objectives specified in D1641 over which the projects have control, or any other orders adopted by the SWRCB.

The total quantity of water delivered to SWP or CVP contractors as a result of the change will not exceed historic deliveries to any individual water user or be applied to any service areas that do not already receive water from the SWP or CVP. The petition will not result in a reduction in San Joaquin flows, an increase in Delta exports or a change in upstream river or reservoir operations. The petition will not change groundwater pumping levels, as AEWSD is proposing to pump water that has been previously stored by MWDSC. None of the agencies involved in the proposed exchange return flow to the San Joaquin River.

For the above reasons, Reclamation believes the facts support a finding that approval of this Petition would not result in injury to other legal water users or unreasonable impacts to the environment.

1b. The Amount of Water to be Transferred/Exchanged Would Have Been Consumptively Used or Stored in Absence of the Transfer.

The water to be exchanged under this petition is water that would be consumptively used absent this petition. This petition is to facilitate source shifting—the only change is where the water is consumptively used, not whether it is consumptively used (see Reason for Change, above).

3a. Analysis of Potential Changes in Streamflow, Water Quality, Timing of Diversions of Use, Return Flows and Effects on Legal Users

The change requested by Reclamation will not result in any measurable changes to streamflow, water quality, timing of diversion of use, or return flows. There will be no impact to other legal users of water. The water has been diverted out of the watershed from which it originates in conformance with the provisions of the respective DWR and Reclamation water rights permits and license governing SWP and CVP (including Friant) operations. There are no other legal users downstream of the points of diversion that would be affected by the proposed exchange. All the water to be exchanged is water that would have been consumptively used or stored in the absence of the proposed exchange. The total quantity of water diverted from the watercourse will not change. Exchanges similar to this proposed action were conducted in 2009 and 2010 in accordance with orders WR 2009-0033 and WR 2010-00320DWR approving DWR and Reclamations' Petition to Consolidate the authorized places of use of the SWP and CVP. No measurable affects on other legal users of water, fish and wildlife or the environment were noted from past exchanges.

3b. Reasons the Proposed Temporary Change will not Injure Any Legal User of Water

There will be no impact to other legal users of water. The water has been diverted out of the watershed from which it originates in conformance with the provisions of the respective DWR and Reclamation water right permits and license governing those diversions. The quantity of water diverted from the Delta will not change as a result of the proposed transfers/exchanges. The terms and conditions contained in D1641 protect other in-basin diverters from any potential impacts of Project diversions of natural flow. DWR and Reclamation will continue to operate in conformance with D1641. There are no other legal users downstream of the points of diversion that would be affected by the proposed exchange.

All the water to be exchanged is water that would have been consumptively used or stored in the absence of the proposed exchange. The total quantity of water diverted from the watercourse will not change. Exchanges similar to the proposed were conducted in 2009 and 2010 in accordance with orders WR 2009-0033 and WR 2010-00320DWR approving DWR and Reclamations' Petition to Consolidate the authorized places of use of the SWP and CVP.

5b and c. The Transfer Will Not Result in Unreasonable Impacts to Fish and Wildlife or the Environment

The change requested by Reclamation will not result in unreasonable impacts to fish and wildlife or the environment and will not result in injury to legal users of water.

This petition will not result in any increase in water appropriated by the CVP. Instead, this petition, if approved, would provide the CVP with more flexibility to deliver water to its contractors in a more efficient manner. All water exported at the SWP and CVP pumping plants will continue to be pumped consistent with the criteria and protective measures contained in D1641, the biological opinions for the protection of Sacramento River Winter-run Chinook salmon, Delta smelt, spring-run Chinook salmon, and steelhead. Approval of Reclamation's petition for a temporary change to place of use will not affect the compliance with the water quality objectives specified in D1641 over which the projects have control, or any other orders adopted by the SWRCB.

The total quantity of water delivered to SWP or CVP contractors as a result of the change will not exceed historic deliveries to any individual water user or be applied to any service areas that do not already receive water from the SWP or CVP. The petition will not result in a reduction in San Joaquin flows, an increase in Delta exports or a change in upstream river or reservoir operations. The petition will not change groundwater pumping levels, as AEWSD is proposing to pump water that has been previously stored by MWDSC. None of the agencies involved in the proposed exchange return flow to the San Joaquin River.
