

Yuba County Water Agency (YCWA) would remain the sole permittee. The purpose of this temporary urgency petition is to enable San Luis & Delta-Mendota Water Authority (SLDMWA) and members to store Yuba Accord water in San Luis Reservoir from the current Central Valley Project (CVP) contract year into the next CVP contract year. This CVP contract year ends on February 28, 2014 and the next year begins on March 1, 2014. In Corrected Order WR 2008-0014, the SWRCB approved transfers of Yuba Accord water by approving, among other things, the addition of the CVP's service area to Permit 15026's place of use and the addition of the CVP's and SWP's south Delta pumping plants as points of rediversion on that permit. ATTACHMENT TO PETITION OF YUBA COUNTY WATER AGENCY TO ADD A POINT OF REDIVERSION TO PERMIT NO. 15026

County

The permanent existing authorized points of diversion for Permit 15026 are located in Sierra and Yuba Counties with authorized points of rediversion in San Joaquin County added until December 31, 2025 by Corrected Order WR 2008-0014. The proposed additional authorized temporary point of rediversion is in Merced County.

Proposed New Point of Rediversion

The proposed authorized temporary point of rediversion would be located on San Luis Creek at the point of diversion for San Luis Dam within the SW ¼ of SE ¼ of projected section 15, T10S, R8E, MDB&M at North 1,845,103 feet and East 6,393,569 feet by California Coordinate System in Zone 3 (NAD 83).

This point of rediversion would be added to water-right Permit 15026 until 180 days following the SWRCB's approval of that point of rediversion. If necessary to enable the full use of the water that would be stored in San Luis Reservoir pursuant to this petition, if approved, Yuba County Water Agency (YCWA) will consider petitioning for renewal of the proposed authorized temporary point of rediversion or for that change to be made on a long-term basis.

Place of Use

In Corrected Order WR 2008-0014, the SWRCB approved the addition of the authorized place of use of the Central Valley Project (as shown on map 214-208-12581 on file with Application 5626) to YCWA's Permit 15026 through December 31, 2025. The proposed authorized temporary point of rediversion would be used to enable storage of water for use within this CVP place of use.

<u>Urgent Need That Is Basis for Urgency Petition</u>

The urgent need for this petition is described in the attached memorandum from the San Luis & Delta-Mendota Water Authority (SLDMWA).

The water that would be stored into the 2014-2015 CVP contract year is already present in San Luis Reservoir as a result of 2013 diversions of Yuba Accord water from the Delta under Corrected Order WR 2008-0014. Accordingly, no legal users of water will be injured by the proposed temporary urgency change.

San Luis Reservoir is an off-stream reservoir with approximately 2,000,000 acre-feet of storage capacity. The proposed temporary urgency change would enable the storage of approximately 7,353 acre-feet of water in that reservoir for a longer time. YCWA is preparing an addendum to the Yuba Accord EIR (SCH #200506211). In light of the fact that San Luis Reservoir is an off-stream reservoir, the relevant water is already stored in San Luis Reservoir, that water is a very

small portion of the reservoir's storage capacity and that water would be stored for a somewhat longer period of time, YCWA believes that approval of this petition would not have any unreasonable effects on fish, wildlife or instream uses.

Access to Proposed Point of Rediversion

The water that would be stored into the 2014-2015 CVP contract year as a result of the proposed addition of the authorized temporary point of rediversion is Yuba Accord water that SLDMWA has purchased from the Department of Water Resources. SLDMWA anticipates acquiring the right to store that water in San Luis Reservoir into the 2014-2015 CVP contract year by executing a Warren Act contract with the U.S. Bureau of Reclamation (Reclamation) to use a portion of Reclamation's storage space in the reservoir. Reclamation has informed SLDMWA that the addition of the proposed authorized temporary point of rediversion to YCWA's Permit 15026 is necessary for the Warren Act contract.

Proposed Terms of Approval of Addition of New Temporary Point of Rediversion

YCWA proposes that the SWRCB's approval of the addition of the proposed new authorized temporary point of rediversion include the following terms:

- 1. The new authorized temporary point of rediversion at San Luis Dam is added until 180 days following the SWRCB's approval of that addition to Permit 15026. The maximum quantity of water that may be stored in San Luis Reservoir as a result of the addition of the new authorized temporary point of rediversion is 7,400 acre-feet.
- 2. Diversions at the new authorized temporary point of rediversion are subject to all terms of any biological opinions and incidental take permits that apply to the operation of San Luis Reservoir by the U.S. Bureau of Reclamation and the Department of Water Resources.
- 3. The addition of San Luis Dam as an authorized point of rediversion shall not authorize any diversions of water under Permit 15026 at Clifton Court Forebay and Jones Pumping Plant besides those authorized by Corrected Order WR 2008-0014.
- 4. By November 1, 2015, YCWA shall provide to the Deputy Director a report describing the storage of water in San Luis Reservoir pursuant to the addition of San Luis Dam as an authorized temporary point of rediversion in Permit 15026.
- 5. This order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish and Game Code sections 2050 to 2097) or the federal Endangered Species Act (16 U.S.C.A sections 1531 to 1544).



Reason for Temporary Urgency Petition

Members of San Luis & Delta-Mendota Water Authority (SLDMWA) have conserved up to 7,353, acre-feet (AF) of Yuba Accord water that they purchased in 2013 from the Department of Water Resources under the Agreement For the Long-Term Purchase of Water From Yuba County Water Agency by the Department of Water Resources. Those SLDMWA members seek to store that 2013 Yuba Accord water to increase their 2014 supplemental supplies. They anticipate that the Bureau of Reclamation's February 2014 allocation to the South of Delta CVP Agriculture Service Contractors in 2014 will be 0%. Those SLDMWA members have aggressively conserved 2013 Yuba Accord water to store it in San Luis Reservoir for use in 2014. Reclamation will allow for the storage of Yuba Accord water in San Luis Reservoir under a Warren Act Contract if the State Water Resources Control Board (SWRCB) adds that reservoir as a point of rediversion on Yuba County Water Agency's (YCWA) Permit 15026.

During the three-month (July-September) transfer window when Yuba Accord water was conveyed through the Delta, Westlands Water District (Westlands), Pacheco Water District (Pacheco), and Panoche Water District (Panoche) were able to reduce demands, with the intent of conserving Yuba Accord water for 2014, as forecasts during that period were already suggesting very low allocations in 2014. With the current, critically dry hydrologic conditions, Westlands, Panoche, and Pacheco now anticipate no CVP allocation in 2014. Therefore, the ability of those districts to store and reschedule transfer water is imperative. If YCWA's urgency petition was not granted, then 7,353 AF could not put to beneficial use in 2014, harming farmers within the districts by stranding at last in part the investments in Yuba Accord water and forcing the fallowing of nearly 3,000 acres of productive farm land. Such fallowing would result in the loss of agriculture—related jobs in the areas served by Westlands, Pacheco and Panoche in Fresno, Merced and Kings Counties—among the most economically vulnerable populations in the State.

Denying this petition would also prevent Westlands, Pacheco and Panoche from completing other transfers that bring supplemental water into the districts because having the ability to store Yuba Accord water would free up capacity on delivery schedules. Many of these additional transfers must be delivered "on-pattern" and cannot be stored, rescheduled, or shown delivered in future months. Once the opportunity for executing these transfers is lost, they cannot be recovered in future months. By storing Yuba Accord water, the districts can exercise multiple water management strategies to efficiently and beneficially use water to the greatest extent.
