NOTICE OF PETITION FOR RENEWAL OF TEMPORARY URGENCY CHANGE FOR LICENSE 9847 (APPLICATION 17913)

COUNTY: Santa Cruz STREAM SYSTEM: San Lorenzo River

The City of Santa Cruz has filed a temporary urgency change petition, pursuant to Water Code Section 1435, with the State Water Resources Control Board (State Water Board), Division of Water Rights (Division). The petition requests that the 1.0 cubic foot per second (cfs) bypass or release amount required by License 9847 be temporarily reduced to 0.2 cfs for a period of 180 days due to current severe drought conditions. Place of Use:	At Newell Creek Reservoir (aka Loch Lomond) and in the San Lorenzo Basin, including upper San Lorenzo Valley, Scotts Valley and Santa Cruz, T8S, T9S, T10S, and T11S, R1W, R2W, and R3W, all within MDB&M
