**NOTICE OF PETITION FOR TEMPORARY CHANGE INVOLVING THE TRANSFER OF UP TO 1,000 ACRE FEET OF WATER FROM EAST BAY MUNICIPAL UTILITY DISTRICT TO NORTH SAN JOAQUIN WATER CONSERVATION DISTRICT UNDER WATER RIGHT PERMIT 10478 (APPLICATION 13156)**

COUNTIES: Amador, Calaveras, and San Joaquin  
 STREAM SYSTEM: Mokelumne River

On January 16, 2018, East Bay Municipal Utility District (EBMUD) filed with the State Water Resources Control Board, Division of Water Rights (Division) a petition for a temporary change to water right Permit 10478, requesting to transfer water pursuant Water Code section 1725, et seq. With the petition, EBMUD seeks authorization to temporarily transfer up to 1,000 acre-feet of water previously collected to storage in Camanche Reservoir to North San Joaquin Water Conservation District (NSJWCD) for irrigation purposes. Farmers within NSJWCD will use the transferred water to irrigate their crops in lieu of pumping groundwater for irrigation during the 2018 irrigation season. EBMUD also requested the transferred water be dedicated for instream use in the Mokelumne River between Camanche Dam downstream to the to the NSJWCD South Pump Station, pursuant to Water Code section 1707.
