RE-NOTICE OF TEMPORARY WATER RIGHT PERMIT APPLICATION T032962

COUNTY: Madera

STREAM SYSTEM: San Joaquin River

This is a re-notice of Temporary Water Right Permit Application T032962, which was originally noticed on October 12, 2018. The subject application is being re-noticed to correct errors and omissions in the original notice and application. Specifically, Point of Diversion 4b has been added to the notice, and the legal description of Points of Diversion 2, 3, 5, 6, and 8 have been modified in the notice and application to accurately correspond to the application maps. Additionally, the application maps have been revised to include labels for the Points of Diversion. The time period allowed for filing written objections against approval of the subject application has been extended accordingly. Objections submitted pursuant to the original notice need not be resubmitted unless amendments to existing objections are desired.

Aliso Water District (Applicant) filed a temporary water right permit application on August 16, 2018 (revised on October 4, 2018) to appropriate surface water flows for underground storage, pursuant to Water Code section 1425. Pursuant to Water Code section 1428, the State Water Board may issue a temporary permit in advance of public notice. Consequently, a temporary permit may be issued on the application before the end of the noticing period.
