

Chapter 3

Indices of Commenters (Part 1)

The following indices list the comment letter numbers and titles of commenters, when provided, from federal agencies and elected officials; tribal governments; state agencies and elected officials; local agencies and elected officials; non-governmental organizations; and members of the public, and include form plus letters and form letter commenters. These indices are organized by organization, commenter name, and letter number. Readers should use these indices to identify the letter number or numbers associated with their submissions and then find the comments and responses in the comment response tables that are contained in Volume 3, Chapter 4, *Responses to Comment Tables*. Indices are organized by commenter type as described in Table 3-1. If a “/” is shown in the table, it is meant to indicate that the information was not provided or was not legible if it was handwritten. Similarly, if a blank is shown in the table, the information was not provided or was not legible.
