Numerous parties contacted the hearing officers regarding submitting WaterFix Part 2 opening statements after the November 30, 2017 submittal deadline. The hearing team discussed this matter with the hearing officers and they have asked us to provide the parties with the following clarification:

(1) Opening statements are intended to present an overview of a party's case-in-chief and are encouraged, but they are optional; (2) parties who intend to present an opening statement during Part 2 of the hearing, however, must submit their opening statement in writing by the deadline imposed by the hearing officers; and (3) the hearing officers have extended the deadline for written opening statements for all parties to **12:00 noon, December 18, 2017**.

Written opening statements may be submitted and served on the other parties through email. They do not need to be uploaded to the FTP site. Please remember to include a statement of service with any submittals.
