Dear Mr. Mizell, Ms. Ansley, and Ms. Morris,

In DWR Part 2 Rebuttal Exhibit 1217, dated July 10, 2018, Metropolitan Water District of Southern California employee Chandra Chilmakuri addresses the Part 2 Testimony of Dr. Susan Paulsen submitted on behalf of the Sacramento Regional County Sanitation District (Regional San). In his testimony, Dr. Chilmakuri asserts:

As pointed out during DWR's cross-examination, SRCSD did not submit the underlying SRWTP operations model that was used to generate the results that form basis of Dr. Paulsen's opinion. At request of DWR, SRCSD agreed to provide the SRTWP operations model along with James "Tripp" Mizell Jolie-Ann Ansley Stefanie Morris

detailed inputs, outputs and assumptions and any evidence of independent review of this model during the cross-examination. (Transcript Volume 20, page 59.) *However to date, SRCSD has failed to provide this information.* (Exhibit DWR 1217, p. 18:16-21, emphasis added)

As shown by the attached correspondence, on April 16, 2018, our office provided each of you with the information requested during DWR's cross examination. Regional San went to considerable effort to provide you, nearly three months ago, with the information you requested. Dr. Chilmakuri's assertion that Regional San failed to provide the requested information is simply not correct.
