18	Diversion for California Water Fix. NDC also joined in the objections of the County of
19	San Joaquin, Delta Protestants, Sacramento Valley Users, Save the California Delta
20	Alliance, Friends of the River, Sierra Club California, AquAlliance, Pacific Coast
21	Federation of Fishermen's Associations, Institute for Fisheries Resources, Earthjustice,
22	and Restore the Delta to all written testimony and exhibits submitted by DWR and
23	Reclamation.
24	NDC is not listed as a participating party in Part 1, but instead is an interested
25	person that is intending to make a policy statement only. The May 11, 2016 Second
26	Revised Hearing Notice indicated that objections would be received "from parties to the
27	hearing." (See p. 2, emphasis in original.) On June 10, 2016, the State Water Resources

1	Control Board ("Board") issued a ruling, stating that "any motions to disqualify any of
2	petitioners' witnesses, or to exclude a witness's testimony, in whole or in part, must be
3	filed and served on petitioners and the other parties by 12:00 noon on July 12, 2016."
4	Even if NDC were a party rather than an interested person, it submitted objections on
5	July 19, 2016, one week after the July 12, 2016 deadline. For the above reasons, NDC's
6	objections should be disregarded and/or overruled.
7	Petitioners suggest that NDC review DWR's Master Response to Objections dated
8	July 20, 2016 and separate Responses to Protestants dated July 22, 2016, all of which
