The South Delta Water Agencies Parties are in receipt of DWR's correspondence of August 3, 2017 requesting that the Hearing Officers notice the commencement of Part 2 of the California Water Fix Change Petition Proceedings. The South Delta Water Agency Parties are also in receipt of the correspondence submitted by California Delta Alliance ("Delta Alliance") on August 3, 2017 in response thereto. The SDWA's Parties join in the Delta Alliances' letter and reiterate that DWR's request is extremely premature and directly contrary to the Hearing Officers' previous rulings with respect to the information which must be readily available and the processes which must be completed prior to the commencement of Part 2. DWR's request to notice Part 2 of the proceedings is inappropriate and should be denied.


