Dear Hearing Officers:

Save the California Delta Alliance appreciates the Hearing Officer's attention to its correspondence regarding scheduling of Part 2 of the hearings, and agrees with the Hearing Officer's decision to allow DWR a chance to answer Delta Alliance before making any decisions. Delta Alliance believes that all sides should be given a fair chance to be heard.

However, the Board has allowed Delta Alliance only 24 hours to reply to DWR's answer with very little advance notice. The undersigned has an out-of-town schedule conflict on Thursday afternoon and evening and will be unable to work on any reply during that time period.

Delta Alliance respectfully requests that its reply due date be extended by one working to noon on Monday July 14, and that DWR's deadline likewise be extended to Friday July 11 at noon (or any other similar short and equitable extension that the Board feels is appropriate).

Delta Alliance has only one solo-practioner attorney and believes that the Board would be better served by a reasoned reply rather than deciding an issue one way or the other because one side's attorney was rushed.
