

The City of Stockton (City) appreciates the California Waterfix Hearing Officers' August 10, 2017 ruling (Ruling) overruling the Department of Water Resources' (DWR) objection and motion to strike certain cross-examination questions by the City and Local Agencies of the North Delta et al. (LAND) of DWR witness Dr. Parviz Nader Tehrani and related exhibits, including exhibits STKN-51, STKN-52 and STKN-53, presented on June 15, 2017. 
