ORDER

APPLICATION 4635PERMIT 2268LICENSE 1289

ORDER ALLOWING CHANGE IN POINTS OF DIVERSION

WHEREAS License 1289 was issued to Alfred S. Ferguson and William C. Ferguson and was filed with the County Recorder of Contra Costa County on March 28, 1933, and

WHEREAS said license was subsequently assigned to Elmer L. and Claire L. Danielson, and

WHEREAS the State Water Resources Control Board has found that the change in points of diversion under said license for which petition was submitted on December 6, 1968, will not operate to the injury of any other legal user of water, and

WHEREAS the Board has approved and allowed said change and has directed that an order be issued to describe said points of diversion in accordance with said petition;

NOW THEREFORE IT IS ORDERED that permission be and the same is hereby granted to change the points of diversion under said License 1289 to points of diversion described as follows, to wit:

1. ON WESTERN CANAL - N83°30'E, 10,000 FEET FROM NE CORNER OF SECTION 25, T1S, R3E, MDB&M, BEING WITHIN SE $\frac{1}{4}$ OF SE $\frac{1}{4}$ OF PROJECTED SECTION 20, T1S, R4E, MDB&M
2. ON DELTA MENDOTA CANAL - SOUTH 87 FEET AND EAST 3,945 FEET FROM W $\frac{1}{4}$ CORNER OF PROJECTED SECTION 30, T1S, R4E, MDB&M, BEING WITHIN THE NW $\frac{1}{4}$ OF SE $\frac{1}{4}$ OF SAID SECTION 30.

APPLICATION 4635PERMIT 2268LICENSE 1289

ORDER ALLOWING CHANGE IN POINTS OF DIVERSION

Licensee having established to the satisfaction of the State Water Rights Board that the change in points of diversion under Application 4635, Permit 2268, License 1289 for which petition was submitted on June 3, 1957 will not operate to the injury of any other legal user of water, the State Water Rights Board so finds, and

IT IS ORDERED THAT permission be and the same is hereby granted to change the points of diversion under said Application 4635, Permit 2268, License 1289 to points of diversion described as follows, to wit:

- (1) ON WESTERN CANAL—NORTH FIFTY-THREE DEGREES TWENTY MINUTES EAST ($N53^{\circ}20'E$) FIVE THOUSAND AND THIRTY (5030) FEET FROM THE SW CORNER OF PROJECTED SECTION 20, T1S, R4E, MDB&M, BEING WITHIN THE $SE\frac{1}{4}$ OF $NE\frac{1}{4}$ OF SAID SECTION 20, and
- (2) ON DELTA MENDOTA CANAL—SOUTH EIGHTY-SEVEN (87) FEET AND EAST THREE THOUSAND NINE HUNDRED FORTY-FIVE (3945) FEET FROM THE WEST $\frac{1}{4}$ CORNER OF PROJECTED SECTION 30, T1S, R4E, MDB&M, BEING WITHIN THE $NW\frac{1}{4}$ OF $SE\frac{1}{4}$ OF SAID SECTION 30.
