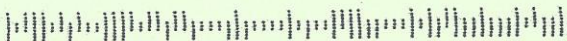

Dear Ms. Candela-Cooney,

Thank you for your letter of 2-14-17. Unfortunately, your answers were vague. We hope you can clarify your responses.

First you said " I found that the Delta Field Division pumps are maintaining ground water levels at appropriate levels within our seepage basins and channels." What does appropriate levels mean? Can you quantify what an appropriate level is and why it is appropriate? Specifically, how deep is "seep" pump 6? What type of pump is it? How far down do you drain the seepage water? What is the purpose of "seep" 6?

Next you said, "The seep basin is currently at the level it is supposed to be." Again, what does this mean? Please quantify what the levels are. What is the purpose of the seep basin?

Then you say "Based on the Field Division staff investigation, it does not appear that DWR facilities are a source of seepage on your property." Are you kidding? Where else would seepage on farm land in the middle of Clifton Court come from except from the adjacent Clifton Court Forebay? We have 635 acres of land surrounded by water on three sides: about a mile of our property line is adjacent to Clifton Court Forebay; about a mile of our property line is adjacent to Old River; about a half mile of our property line is adjacent to the Delta Mendota Canal. Our only problems with seepage come from our fields that are adjacent to the Clifton Court Forebay. We never had problems before the Forebay was built.

You may not be aware that when the State took half of our farm for the Forebay in the 1960's, they mined sand from some of our condemned fields to make concrete treated base that they used to line the Forebay. Knowing the concrete would fail and that part of the ground beneath the Forebay was porous, my father requested a cutoff wall. He was denied. The improperly

built Clifton Court Forebay has leaked and caused problems ever since. DWR needs to install more than one pump along our mile of property on the south side of Clifton Court. An effective seepage pump would drain water from properties on both sides of the cyclone fence to a farmable level.

This past year, our farmer was unable to grow the crops he planted on 25 acres of land due to seepage. An additional 15 acres of crops were marginal due to seepage. We did not receive rent on 25 acres, our farmer did not harvest crops as a result of the Forebay leaking.

This summer at the California WaterFix hearings, DWR lawyer, Tripp Mizell, claimed that the current State Water Project makes people whole if there are any injuries caused by its operation.

We need to be made whole for the injuries we suffered, and we need to have the seepage issue permanently fixed so that we will be able to farm all of our land in 2017.

We look forward to your timely reply.
