Figure M15-1: Index **Recreation Facilities — Pipeline/Tunnel Alignment**




Figure M15-1: Sheet 1 of 7 **Recreation Facilities — Pipeline/Tunnel Alignment**




Figure M15-1: Sheet 2 of 7 Recreation Facilities — Pipeline/Tunnel Alignment




Figure M15-1: Sheet 3 of 7 Recreation Facilities — Pipeline/Tunnel Alignment




Figure M15-1: Sheet 4 of 7 **Recreation Facilities — Pipeline/Tunnel Alignment**





Figure M15-1: Sheet 5 of 7 Recreation Facilities — Pipeline/Tunnel Alignment





Figure M15-1: Sheet 7 of 7 Recreation Facilities — Pipeline/Tunnel Alignment




Figure M15-2: Index **Recreation Facilities — East Alignment**





Figure M15-2: Sheet 3 of 7 Recreation Facilities — East Alignment

Figure M15-2: Sheet 4 of 7 Recreation Facilities — East Alignment






Figure M15-2: Sheet 5 of 7 Recreation Facilities — East Alignment

Figure M15-2: Sheet 6 of 7 **Recreation Facilities — East Alignment**



Figure M15-3: Index Recreation Facilities — West Alignment






Figure M15-3: Sheet 1 of 8 Recreation Facilities — West Alignment








Figure M15-3: Sheet 5 of 8 Recreation Facilities — West Alignment


Figure M15-3: Sheet 6 of 8 Recreation Facilities — West Alignment





Figure M15-4: Sheet 1 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)





Figure M15-4: Sheet 2 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)

Figure M15-4: Sheet 4 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)




Figure M15-4: Sheet 5 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)




Figure M15-4: Sheet 6 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)




Figure M15-4: Sheet 7 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)





Figure M15-4: Sheet 8 of 8 Recreation Facilities — Modified Pipeline/Tunnel Alignment (Alternative 4)



Figure M15-5: Sheet 1 of 5 Recreation Facilities — Through Delta/Separate Corridors




Figure M15-5: Sheet 2 of 5 Recreation Facilities — Through Delta/Separate Corridors






Figure M15-5: Sheet 3 of 5 Recreation Facilities — Through Delta/Separate Corridors
