All of the alternatives evaluated in the EIR/EIS would only divert water under existing water rights that were issued to DWR and Reclamation by the State Water Board with consideration for senior water rights and Area of Origin laws and requirements. The issue of crops and water use is beyond the scope of the Proposed Project. For more information please refer to the updated draft 2013 California Water Plan's strategy for agricultural water use efficiency, which describes the use and application of scientific processes to control agricultural water delivery and use. Also, refer to Master Response 6 and Appendix 1C for further information on demand management measures, including increasing agricultural water use efficiency and conservation.</p> <p>The project is just one element of the state's long-range strategy to meet anticipated future water needs of Californians in the face of expanding population and the expected effects of climate change. The project is not a comprehensive, statewide water plan, but is instead aimed at addressing many complex and long-standing issues related to the operations of the SWP and CVP in the Delta, including reliability of exported supplies. It is important to note that the project is not intended to serve as a state-wide solution to all of California's water problems, and it is not an attempt to address directly the need for continued investment by the State and other public agencies in conservation, storage, recycling, desalination, treatment of contaminated aquifers, or other measures to expand supply and storage (as described in Section 1.C.3 of Appendix 1C, Demand Management Measures). However, it has not proven viable to secure adequate water supplies to meet California's needs due to high costs and energy demands.</p> <p>Today, desalination creates an estimated 84,000 acre-feet of potable water a year in the state, mostly through treatment of brackish groundwater, which is less salty and cheaper to treat than sea water. In comparison, the proposed project would secure an estimated 4.7 to 5.2 million acre-feet of water to supply more than 25 million people and 3 million acres of farmland.</p> <p>Although the proposed project would not increase the overall volume of Delta water exported, it would make the deliveries more predictable and reliable, while restoring an ecosystem in steep decline. Local water agencies will need to invest in additional strategies and technologies, including desalination, to meet future water demand.</p> <p>The proposed project is one part of a diverse portfolio of strategies needed to meet California's overall water management needs.
