Re: Proposed Groupings and Order of Parties for Cross-Examination in Part 1A, California Waterfix Water Rights Change Petition Hearing

Dear Hearing Chair Doduc and Hearing Officer Marcus:

Protestants AquAlliance, California Sportfishing Protection Alliance, California Water Impact Network, Environmental Justice Coalition for Water, Environmental Water Caucus, Friends of the River, Planning and Conservation League, Restore the Delta and Sierra Club California by this joint letter submit their proposed groupings and order of parties for cross-examination in Part 1A of the Waterfix Change Petition Hearing. These protestants have consulted in an effort to submit logical proposed groupings and order of parties pursuant to the Rulings requiring submission of proposed groupings and order of parties.

Proposed groupings of parties for cross-examination in Part 1A

We propose the following groupings of parties for cross-examination in Part 1A:

Group: California Sportfishing Protection Alliance, California Water Impact Network, and AquAlliance;

Group: Environmental Water Caucus, Friends of the River, Planning and Conservation League, Sierra Club California;

Group: Environmental Justice Coalition for Water (A Group in its own right and interests different and diverse from other protestants);

Group: Restore the Delta (A Group in its own right and interests different and diverse from other protestants).

Protestants do not take a position on groupings of protestants other than those joining in this letter.

Proposed order of parties for cross-examination in Part 1A

We propose the following order of parties for cross-examination in Part 1A:

We are non-profit public interest organizations. We propose that protestant water agencies, water districts and other public agencies cross-examine before our organizations. The public agency protestants have greater resources such as legal counsel, staff and retained experts than do our public interest organizations. Allowing the public agency protestants to go first will be most likely to result in efficient crossexamination, reduce unnecessary repetition, and thus result in the most efficient Hearing process possible. In addition, California Water Research/Deirdre Des Jardins should cross-examine sooner rather than later and, in any event, before our organizations because of her expertise in modeling.

We suggest for order of cross-examination among our proposed groups set forth above in this letter, that our four proposed groups cross-examine in the following order: *first*, California Sportfishing Protection Alliance group; *second*, Restore the Delta group; *third*, Environmental Water Caucus group; *fourth*, Environmental Justice Coalition for Water group.

Except as stated in this letter, protestants do not take a position on the order of groups for cross-examination not on this joint letter with the exception of the general suggestion above, that the public agency protestants go first, and also that California Water Research/Deirdre Des Jardins cross-examine comparatively early during the cross-examination process.

We received earlier this morning a letter from petitioner DWR proposing groupings and order of parties for cross-examination. *First*, we submit that petitioners, who are allied with the Export contractors and adverse to protestants in these proceedings, should be disregarded in their suggestions of groupings and order of parties for cross-examination. It is the true protestants who will be cross-examining whose wishes should be paramount in terms of groupings and order of crossexamination. By true protestants, we mean those, including us, who are opposed to approval of the petition for change of point of diversion to accommodate the Water Fix Delta Water Tunnels. Second, DWR's suggestion that the "Export contractors" should "cross-examine" last, after all of the true protestants, should be ignored. Petitioners want the Water Fix which is proposed for the claimed benefit for the Export contractors who would get the water taken away from the lower Sacramento River and San Francisco Bay-Delta. The Export contractors, if they are allowed to "cross-examine" at all, should be required to proceed as if they are on direct examination, and proceed with or immediately following DWR. The Export contractors have no business advancing petitioners' case in the guise of performing "cross-examination" after all of the true protestants have conducted their cross-examinations.
