
Ms. Doduc and Ms. Marcus,

Because the presentation of witnesses in Part 1B by the San Joaquin River Exchange Contractors will focus only on the subject of the measures and financial support, each of which should be conditions of any approval of the Petition of DWR to assure that through-Delta Flow and Capacity modeled and assured by the Petitioners is in fact maintained, and because our cross-examination of other parties' witnesses does not seem to fall into a natural grouping, we request that the San Joaquin River Exchange Contractors Water Authority continue to be grouped separately for both presentation of testimony and cross-examination.


