The State Water Resources Control Board’s December 19, 2016 Procedural Ruling on Rebuttal Process and Schedule specified that the order of presentation of rebuttal evidence will generally proceed in the same order as Part 1. The City of Stockton (Stockton) (Group 22) and City of Antioch (Antioch) (Group 27) were identified as 14th and 15th in order, respectively, for Part 1. Stockton and Antioch both have submitted rebuttal testimony from Dr. Susan Paulsen. Dr. Paulsen’s testimony addresses similar issues for both parties.
